Pnina Rosenberg is an art historian who teaches art and legacy of the Holocaust at the Technion, Israel Institute of Technology, Haifa.

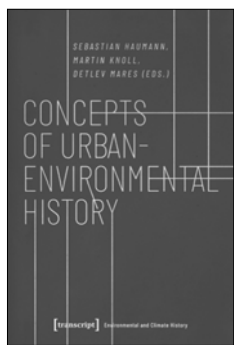
Matthew Stibbe is Professor of Modern European History at Sheffield Hallam University and associate editor of the journal *Immigrants and Minorities*.

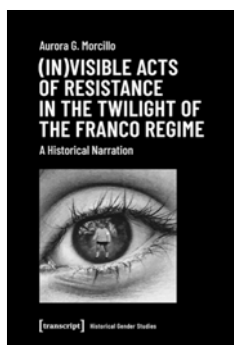
Kim Wünschmann is the Director of the Institute for the History of the German Jews in Hamburg and teaches modern and contemporary history at University of Hamburg.

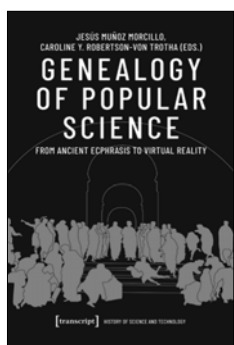

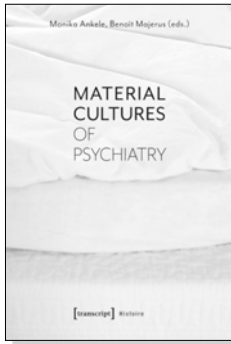

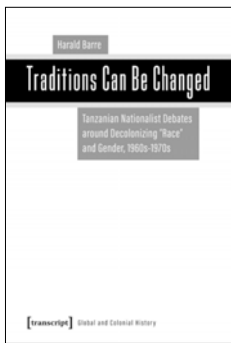
