Prof. Dr. Christina Binder is W3 Professor of International Law and International Human Rights Law at the *Bundeswehr University Munich* since 2017. Previously, she was Professor of International Law at the *University of Vienna* and Deputy Director of the Interdisciplinary Research Center “Human Rights”. Her research focuses on a number of international law issues, including human rights, the law of treaties, international investment law as well as international environmental law. She is co-editor of the *Journal of Human Rights*, the *European Yearbook of International Economic Law*, and the *Hungarian Yearbook of International and European Law*.

Hugo von Essen is an analyst at the *Stockholm Center for Eastern European Studies* (SCEEUS) at the *Swedish Institute of International Affairs* (UI), where he also serves as the manager of the SCEEUS Eastern Europe Policy Project. His research interests include Russia and Eastern Europe, international relations, and foreign and security policy.

Dr. Timo Graf is a military sociologist at the *Bundeswehr Center of Military History and Social Sciences* in Potsdam, where he leads the annual population survey commissioned by the Federal Ministry of Defense. He is also a lecturer at the University of Potsdam in the Master’s program “War and Conflict Studies”. His research focuses on public opinion on foreign, security, and defense policy issues as well as civil-military relations in Germany.

Dr. Markus Kaim is Senior Fellow in the Research Group “Security Policy” at the *Stiftung Wissenschaft und Politik* (SWP) – German Institute for International and Security Affairs, Berlin. He is a lecturer at the *University of Zurich*, at the *Hertie School of Governance*, Berlin, and at the *Bucerius Law School*, Hamburg. His research interests currently include the reorientation of German security and defense policy and the rebalancing of transatlantic security relations.

Dr. Ronja Kempin is Senior Fellow in the “EU/Europe” Research Group at the *Stiftung Wissenschaft und Politik* (SWP) – German Institute for International and Security Affairs, Berlin. Her research interests include Franco-German relations in security and defense policy as well as the role of the *Front National* and populism in France.

Dr. Sarah Kirchberger is Academic Director of the *Institute for Security Policy at Kiel University* (ISPK). She also serves as Vice President of the *German Maritime Institute* and is a Non-Resident Senior Fellow at the *Atlantic Council*. Her research focuses on Russian-Chinese military relations, the development of Chinese armed forces, especially the navy, and on the significance of disruptive technologies in the military.

Prof. Dr. Joachim Krause is Director Emeritus of the *Institute for Security Policy at Kiel University* (ISPK) since July 2023, where he served as Academic Director from 2002. He was Professor for International Relations at *Christian-Albrechts-Universität zu Kiel* (CAU) from 2001 to 2016. He is the founder of the ISPK's "*Terrorism Yearbook*" series and founder and editor of the security studies monthly journal "*SIRIUS – Zeitschrift für strategische Analysen*".

Arthur de Liedekerke is Director of European Affairs at the policy consultancy *Rasmussen Global* and Non-Resident Fellow at the *Institute for Security Policy at Kiel University* (ISPK). He formerly advised senior officials in the French Ministry of Armed Forces and European Union institutions (Commission and Parliament) on security and defense issues. He regularly reports on international relations and geopolitics in international media, including *Politico*, *Euractiv*, *Sky News*, and *Europe1*.

Dr. Tobias Lindner has been Minister of State at the Federal Foreign Office since December 2021. He has been a member of the German Bundestag since 2011; in the 19th legislative period, he was spokesman for security policy for the Bündnis 90/Die Grünen parliamentary group.

Angela Mehrer is Coordinator at the *European Council on Foreign Relations* (ECFR) and is part of the "Re:shape Global Europe" project. She supports Dr. Jana Puglierin in her work on German and European foreign, security, and defense policy and Germany's role in Europe.

Oleksiy Melnyk is Co-Director of the Foreign Policy and International Security Programmes and Coordinator of International Projects at the *Razumkov Centre* in Kyiv, Ukraine. He is a lieutenant colonel in the reserve of the Armed Forces of Ukraine and a participant in the UN peacekeeping missions of 1996–1997. From 2005 to 2008, he served as First Assistant to the Ukrainian Minister of Defense.

Dr. Johanna Möhring is Associate Fellow at the Henry Kissinger Professorship for Security and Strategy Research at CASSIS at the University of Bonn and *Chercheuse associée* at the *Centre Thucydide* in Paris. Her research focuses on European security and defense policy, and power strategies in international politics. She is currently researching statecraft in the 21st century.

Dr. Jana Puglierin is Senior Policy Fellow at the *European Council on Foreign Relations* (ECFR) and Head of the Berlin Office since 2020. She also leads the ECFR project “Re:shape Global Europe”. Her research focuses on German and European foreign, security, and defense policy as well as Germany’s role in Europe and transatlantic relations.

Colonel dG Dr. Markus Reisner, PhD is Head of the Research and Development Department at the *Austrian Theresian Military Academy* and is currently Commander of the Honor Guard of the Austrian Armed Forces. His research focuses on unmanned weapons systems, robotics, and artificial intelligence, tactical and operational lessons from military history, military leadership, disruptive events (e.g. *blackout*) and their consequences, and contemporary history of Austria in 1943–1945. Currently, he serves as one of the media experts of the Federal Ministry of Defense on the Russian war in Ukraine.

Dr. Susanne Spahn is a historian of Eastern Europe and political scientist living in Berlin. After studying Eastern European history, Slavic studies, and political science in St. Petersburg and Cologne, she completed her doctorate in 2011 on Russia’s foreign policy towards Ukraine and Belarus since 1991. She has written six studies on Russia’s information policy and the media, among others on behalf of the *Friedrich Naumann Foundation for Freedom* and MEP Viola von Cramon.

Dr. Marie-Agnes Strack-Zimmermann was a publishing representative of *Tessloff Verlag* in Nuremberg from 1988 to 2008 and has been a member of the FDP since 1990. Since 2013, she has been a member of the Free Democratic Party (FDP) presidium and a member of the federal executive committee, respectively. Dr. Strack-Zimmermann has been active in local politics since 1999. From 2008 to 2014, she served as First Mayor of the state capital Düsseldorf. Since 2017, she has been a member of the German Bundestag and FDP spokesperson for defense policy. Since 2021, Dr. Strack-

Dr. Maximilian Terhalle is Visiting Professor of Geopolitics at the *London School of Economics* (LSE).
