Brox, Trine is an Assistant Professor/Postdoc in Tibetan and Chinese Studies at the Department of Cross-Cultural and Regional Studies, University of Copenhagen (Denmark). With the PhD thesis “The Enchanted Gift of Democracy: Imagining and Negotiating Democracy in the Tibetan Diaspora” (2008), Trine Brox received her PhD degree in Tibetology from the University of Copenhagen.

Fleming, Kenneth is a Scottish theologian. He spent several years living and working in Asia — as a Buddhist monk in a Japanese order and, later, as a Christian minister serving poor, rural congregations in Thailand. The encounter between Buddhism and Christianity, especially in the Asian context, has continued to be a central feature of his personal and academic life, as seen in his book *Asian Christian Theologians in Dialogue with Buddhism* (2002). After several years of working in the Theological Institute of the Scottish Episcopal Church, where he was responsible for the formation of priests and teaching on missiological and interreligious issues, he moved in 2006 to Freiburg (Germany), with his German wife and family. Here he is engaged in a variety of theological translation work for Heidelberg University, further research into Christian-Buddhist issues, and looking after his young children.

Hirsch, Alfred is Associate Professor for Philosophy at the University of Hildesheim and Senior Fellow at the Institute for Advanced Study in the Humanities (KWI) in Essen (Germany). The themes of research focus include violence and conflict theory, philosophy of human rights and intercultural, ethics, and social phenomenology.

He is the author of *Recht auf Gewalt? Spuren philosophischer Gewaltrechtfertigung nach Hobbes* (2004).

Jampa Tsedroen, Bhikṣuṇī (Carola Roloff), born 1959, is a teacher of Buddhist philosophy at the Tibetisches Zentrum Hamburg and a lecturer and research fellow at Hamburg University (Germany), specialising in nuns' ordination and women in Buddhism. She became a novice nun in 1981 and obtained full ordination in Taiwan in 1985. She studied Tibetan Buddhism theory and practice as well as Vinaya with late Geshe Thubten Ngawang (1932-2003) from 1981 to 1996, and then classical Indology and Tibetology at the University of Hamburg, where she received her MA degree in 2003 and her PhD degree in 2009. Meinert, Carmen, Sinologist and Tibetologist, obtained her PhD from the University of Bonn in 2001 with a comparative study on Chinese Chan Buddhism and Tibetan rDzogs chen. Currently she works as a research fellow at the Institute for Advanced Studies in the Humanities (KWI) in Essen (Germany). Her fields of research are Buddhist interchange between China and Tibet, early tantric/esoteric traditions, Dunhuang manuscripts and more recently topics related to Humanistic Buddhism. One of her current research projects focuses on aspects of violence in Tibetan and Chinese tantric Buddhism. Among her recent publications are: "Gangkar Rinpoché between Tibet and China: A Tibetan Lama among Ethnic Chinese in the 1930s to 1950s," in: *Buddhism between Tibet and China* (2009); *Traces of Humanism in China – Tradition and Modernity* (as editor, 2010).

Römer, Stephanie gained her PhD in Political Science at the Free University Berlin (Germany) in 2005. Her research interest focuses on Tibetans in exile, migration, and governments-in-exile. She is the author of *The Tibetan Government in Exile: Politics at Large* (2008).

Schmidt-Glitzner, Helwig, born 1948 in Bad Hersfeld (Germany), studied Sinology, Sociology, Political Science and Philosophy in Göttingen and Munich from 1967 to 1972. He holds a PhD (1973) from the University of Munich. After research in Taiwan and Japan he travelled over land through many Asian and Middle East coun-

tries. In 1979 he finished his Habilitation in Sinology at Bonn University. From 1981 to 1993 he held the Chair for East Asian Languages and Culture at the University of Munich. Since 1993 he is Director of the Herzog August Bibliothek Wolfenbüttel and Professor at Göttingen University. His special interests are in history of religion and symbolic communication. Among his recent publications are: *Wohlstand, Glück und langes Leben. Chinas Götter und die Ordnung im Reich der Mitte* (2009); *Chinas Angst vor der Freiheit. Der lange Weg in die Moderne* (2009).

Schmidt-Leukel, Perry, born 1954, taught at the Universities of Munich, Innsbruck, Salzburg and Glasgow. Since 2009 he is Professor of Religious Studies and Intercultural Theology at the University of Münster (Germany). He has more than 200 scholarly publications in the fields of Systematic Theology, Religious Studies, Inter-Faith Studies and Buddhist-Christian dialogue. Among his most recent books are: *Buddhist Attitudes to Other Religions* (2008); *Transformation by Integration* (2009).

Seeger, Martin, born 1973, is currently lecturer in Thai Language and Culture at the University of Leeds (UK). From 1997 to 2000 he was ordained as a Theravāda Buddhist monk in Chiang Mai, northern Thailand, and subsequently earned his doctorate in Thai Studies at the University of Hamburg. Much of his research focuses on the life and work of the Thai Buddhist thinkers Buddhādāsa Bhikkhu (1906–1993) and Phra Payutto (b. 1938). He has also done research on development monks in the north-eastern region of Thailand and continues to work on the research project “Hagiographical Processes and Religious Symbolism in Modern Thai Buddhism”. His publications include: “The Bhikkhuni-Ordination Controversy in Thailand,” in: *Journal of the International Association of Buddhist Studies* 29 (2008); “The Changing Roles of Thai Buddhist Women: Obscuring Identities and Increasing Charisma,” in: *Religion Compass* (forthcoming).

Shi Zhiru is a Buddhist nun from Singapore who received full ordination in Taiwan. She received her masters degree in Indian Buddhism from the University of Michigan and her doctorate in East Asian Buddhism from the University of Arizona. She is currently Associate Professor in the Department of Religious Studies at Pomona College in California (USA). She is the author of *The*

Making of a Buddhist Savior: Dizang in Medieval China (2007). She has also published articles on Chinese Buddhist cults and contemporary Buddhism in Taiwan.

Sobisch, Jan-Ulrich has studied Tibetology, Indology, and Philosophy at Hamburg University, where he received a Dr. phil. in 1999. In the following years he worked at Hamburg, Munich, and finally Copenhagen University (Denmark), where he is currently Professor for Tibetan Studies. He has researched and published on Tibetan theories of harmonizing *prātimokṣa*, *bodhisattva*, and *mantra* vows (Tib. *sdom pa gsum*), documents of transmission (Tib. *gsan yig*), manuscripts, and the literature on Hevajra and the Path with Its Fruit (Tib. *lam 'bras*) teaching. He presently works on Tibetan handwritten scripts, indigenous tantric theories, and the reception of Indian Buddhism in Tibet between the eleventh and thirteenth centuries.

Zöllner, Hans-Bernd, born 1942, studied physics, theology and sociology at Hamburg, Heidelberg and Göttingen University. From 1970 to 2002 he worked as a Lutheran pastor. From 1983 to 1990 he was assigned minister of the *German Speaking Protestant Congregation* in Thailand. In 1998 he received his PhD from the Department of Southeast Asian Studies of Hamburg University (Germany). Since then, he teaches at various German universities focusing on the modern history and politics of Burma/Myanmar and Theravāda Buddhism.
