Gladkova is a practicing urban planner and organizer of international urban planning workshops. Her research interests include the search for methods, concepts and approaches for the renovation of residential neighborhoods from the 1960 and 1970s, including the interaction of public space, landscape and residential groups and the renovation of public space in residential neighborhoods.

Prof. **Daniel B. Hess**, PhD is a professor in the Department of Urban and Regional Planning at the University of Buffalo, State University of New York. In his research, he develops new pathways for understanding the complex socio-economic and ethnic landscape of cities and spatial inequalities. His research contributes to discussions that seek to re-evaluate relationships between transport and land use to address various pressing societal concerns, including pollution, congestion, and metropolitan sprawl. He accomplishes this by focusing his intellectual inquiry on connections between transportation and land use planning and resulting impacts on health, environment, and social aspects of community. Hess's research spans urban planning history and post-socialist urban space, which he has developed in Estonia and the Baltic States as a Fulbright Scholar in 2011 and in 2016–2017 as a Marie Skłodowska-Curie Fellow at the Centre for Urban and Migration Studies at the University of Tartu, Estonia. Most recently he won a 2023–2024 Fulbright Scholar for teaching and research at Tadeusz Kościuszko University of Technology in Kraków, Poland.

**Knut Höller**, executive Member of the Managing Board Housing Initiative for Eastern Europe (IWO e. V.), is a trained economist and M.B.A. He has profound knowledge of housing policy in Germany as well as in Eastern Europe and Central Asia and has been working in projects in direct cooperation with government institutions in different countries including the Ministry of Regional Development in Ukraine, the Ministries of the Environment in Latvia and Lithuania, the Ministry for Housing and Communal Services in Belarus and a number of public bodies in Uzbekistan and Kazakhstan. He also had regular working relations with the Russian Government, e.g. Ministry of Regional Development prior to 2014. Mr. Höller has profound knowledge and understanding of the decision-making process in Ukraine and with regards to the residential and energy sector also in other transition countries as the Baltic States, Belarus, Russia, Kazakhstan and Uzbekistan. He has a good understanding of

the complex situation after privatization of the housing stock in transition of the housing sector and the energy efficiency in buildings. He actively participated in the development of appropriated national refurbishment programs in the Baltic States and currently in Ukraine. Tammaru theorizes the paradigmatic shift in the study of spatial inequality from residential neighborhood approach to activity space-based approach. Together with colleagues from Delft and Tartu he is developing the concept of the vicious circle of segregation that focusses on how social and ethnic inequality and segregation are produced and reproduced across multiple life domains: homes, workplaces, schools, leisure time activity sites. He is the co-editor of the book *Housing Estates in Europe: Poverty, Ethnic Segregation, and Policy Challenges* (Springer Publishing 2018).

**Maria Tumureeva**, M.A., is an architect and urban planner, as well as a PhD candidate at the Karlsruhe Institute of Technology (KIT) in Germany. Tumureeva holds a bachelor's and master's degree from Irkutsk National Technical University (IRNITU). During her studies, she held internships at KIT's chair of international urban design. Her research is dedicated to exploring and advancing knowledge in the field of spatial development and renovation of mass housing districts built in 1960–1980s. She is also actively

engaged in research projects focused on understanding mass housing heritage and its transformations. She is the author of 15 books and research monographs and over 80 articles, book chapters and research reports on urban policy, regeneration, urban sustainability and housing policy. Throughout her extensive academic and professional career, Dr. Tsenkova's research has influenced the work of academic institutions, governments, public and civil society organizations engaged in the field of housing policy and urban planning in Europe and beyond. Her scholarship is internationally recognized by a number of prestigious awards such as Killam Fellowship, Urban Studies Fellowship, Sasakawa Scholarship, International Peace Scholarship, and Cambridge & Harvard Universities Visiting Fellowship. Dr. Tsenkova is a Fellow of the Canadian Institute of Planners and the leader of two working groups in the European Network for Housing Research.

**Daria Volkova** is a PhD candidate at the Institute for European Urban Studies (IfEU) at Bauhaus University Weimar and an assistant researcher at the Laboratory of Urban Sociology at HSE University in Moscow.
