Clara Berlich researches in aesthetics, feminist and political philosophy. Her doctoral project explores the phenomenon and concept of resistance through an analysis of the reception history and various artistic interpretations of Sophocles' *Antigone*.

Jacob Blumenfeld is a postdoctoral fellow at the Centre for Social Critique at Humboldt University, Berlin, where he co-directs an interdisciplinary research project on socialization. He is the author of *The Concept of Property in Kant, Fichte, and Hegel: Freedom, Right, and Recognition* (Routledge, 2023) and *All Things Are Nothing to Me: The Unique Philosophy of Max Stirner* (Zero Books, 2018). He is the co-editor (with Niklas Angebauer and Tilo Wesche) of *Umkämpftes Eigentum: Eine gesellschaftstheoretische Debatte* (Suhrkamp, 2025) and (with Chiara Bottici and Simon Critchley) of *The Anarchist Turn* (Pluto Press, 2013).

Hilke C. Hänel teaches and researches at the University of Potsdam in political and social epistemology, feminist philosophy, political theory and applied ethics with a focus on migration and disability. She is the author of several papers and books, including a recent book on epistemic injustices and epistemic oppression, and co-editor of two book series as well as the *Journal of Social Ontology*.

José Medina is Walter Dill Scott Professor of Philosophy at Northwestern University. His primary fields of expertise are critical philosophy of race, feminist and queer theory, social epistemology, and political philosophy. Medina's latest book is *The Epistemology of Protest: Silencing, Epistemic Activism, and the Communicative Life of Resistance* (OUP, 2023). Previous books include *The Epistemology of Resistance: Gender and Racial Oppression, Epistemic Injustice, and Resistant Imagina-*

tions (OUP, 2013), recipient of the North-American Society for Social Philosophy Book Award.

Karen Ng is Associate Professor of Philosophy at Vanderbilt University. Her research focuses on post-Kantian philosophy and critical theory. Her first book, *Hegel's Concept of Life: Freedom, Self-Consciousness, Logic*, was published by Oxford University Press in 2020 and won the 2021 *Journal of the History of Philosophy* Book Prize.

Breno Santos is philosophy professor at the Federal University of Mato Grosso (UFMT) in Brazil, mainly working on Social and Political Epistemology, Philosophy of Science, and Political Theory. He's the Head of the Philosophy Graduate Program at UFMT and General Secretary to the local branch of the Teachers' Union.

Fabian Schuppert is Professor of Political Theory at the University of Potsdam, Germany. Fabian works on issues in political philosophy, climate ethics, as well as political economy.
