Beham, Markus P., Dr iur., Dr phil., is Professor of Public Law, International and European Law at the European University Viadrina. He has authored numerous publications in the fields of international and EU law, including textbooks and materials collections.

Cottier, Thomas, Dr iur., Dr h.c. mult., LL.M., is Emeritus Professor of European Law and International Economic Law at the University of Bern and served as Adjunct Professor of Law at the University of Ottawa. He founded and directed the interdisciplinary World Trade Institute in Bern. His scholarly focus includes international law, international constitutional theory and the external economic law of the EU and Switzerland, reflected in more than 300 academic publications. His practical work lies in international WTO dispute settlement, currently as a member of the MPIA Pool of 10 Arbitrators, and from 1986 to 1993 as a Swiss negotiator with the EU and within the framework of the GATT, serving as legal counsel of the Federal Department of External Economic Relations and Deputy-Director-General of the Intellectual Property Office at the Federal Department of Justice. He studied in Bern (admitted as an attorney), at the University of Michigan, and the University of Cambridge. He is President of the association La Suisse en Europe and co-author of the *Neutrality 21* manifesto. His last rank in the Swiss Armed Forces was Colonel of Infantry.

Haider-Quercia, Ulrike, Dr, Dr, is Professor of Comparative Public Law at Università Guglielmo Marconi in Rome, where she coordinates the doctoral programme in Legal and Political Sciences. She is a member of the editorial board of the journal *Percorsi costituzionali*, co-founder and active coordinator of the Italian-Austrian Forum for Comparative Law, a member of leading scholarly associations, and the author of numerous academic publications in the fields of comparative constitutional law and democracy.

Hilpold, Peter, Dr, Professor of Public International Law, European Law, and Comparative Public Law at the University of Innsbruck and Professor of International Law at the University of Pavia. He completed studies in law, business administration, economics, and the humanities. He is editor of the journal *Europa Ethnica* (Nomos) and author of more than 350 publica-

tions, including the monograph *Solidarität und Neutralität im Vertrag von Lissabon* (Vienna/Baden-Baden/Bern 2010).

Janik, Ralph, Mag. Phil., Dr. iur., LL.M., is an Assistant Professor of International Law at Sigmund Freud Private University Vienna. He also teaches at the University of Vienna, Andrásy University Budapest, and the University of the Bundeswehr in Munich. His research focuses on war, human rights, the theory of international law, and international relations.

Jorio, Marco, Dr phil., Dr h.c., served as Editor-in-Chief (1988–2014) of the 13-volume *Historical Dictionary of Switzerland* (HLS), published in German, French, and Italian, as well as of the two-volume *Romansh Lexicon Istoric Retic* (LIR). Since 2015 he has worked as an independent historian. In 2023 he published a 500-page history of neutrality entitled *Die Schweiz und ihre Neutralität. Eine 400-jährige Geschichte*.

Luif, Paul, Dr.iur., Doz. Political Science, was assistant professor for international relations at Salzburg University, 1974–1980 and a member of the scientific staff of the Austrian Institute for International Affairs, Vienna, 1980-2013. He is lecturer at the University of Vienna. His main topics of research are the European Union (in particular the Common Foreign and Security Policy as well as Justice and Home Affairs) and the foreign policies of (neutral) small states. He published a 400 pages book on the accession of Austria, Finland and Sweden to the European Union in 1995: *On the Road to Brussels*.

Mohler, Markus, Dr iur., is a former lecturer in public law, with a particular focus on security and police law, at the Universities of Basel and St Gallen. He also taught for several years at the University of Belgrade (policing in the context of the ECHR) and previously served as a police commander. He has published extensively on issues of the rule of law, fundamental rights, and aspects of international law, in particular regarding the adoption of Schengen law. For many years he was Senior Consultant to the Swiss Agency for Development and Cooperation (DEZA) within the Swiss Federal Department of Foreign Affairs (EDA) on justice and police reform projects in countries in Africa and the Western Balkans.

Oeter, Stefan, Dr iur., is Professor of Public Law and Public International Law and Director of the Institute for International Affairs at the University of Hamburg. His research interests include comparative federalism, the protection of linguistic and cultural minorities, international humanitarian

law, and theories of international law and international relations. He chairs the Historical Commission of the International Society for Military Law and the Laws of War, is a member of the Permanent Court of Arbitration (The Hague), and served from 1999 to 2017 as the German member, and from 2006 to 2013 as Chair, of the Council of Europe's independent expert committee on the European Charter for Regional or Minority Languages. Since summer 2025 he has been Vice President of the Academy of Sciences and Humanities in Hamburg.

Rhinow, René, Dr iur., served, among other roles, as legal adviser to the cantonal government and subsequently as President of the Administrative Court of Basel-Landschaft. He was Professor (Ordinarius) of Constitutional and Administrative Law at the University of Basel (1982–2006), a member of the Swiss Council of States for the Canton of Basel-Landschaft (FDP) from 1987 to 1999, and President of the Council of States in 1999. He was President of the Swiss Red Cross (2001–2011) and Vice President of the International Federation of Red Cross and Red Crescent Societies (2006–2011). He later served as ombudsman for CH Media (2012–2020) and as President of the Alzheimer Association Beider Basel. As a Colonel on the General Staff, he last served as head of the Strategy section of the Army Staff.

Saxer, Urs, Dr, LL.M. (Columbia University, New York), is Professor of Public International Law, Constitutional Law, Administrative Law, and Media Law at the University of Zurich and member of the Schindler Centre for International Law at the University of Zurich. He has published widely, in particular on media and platform regulation, freedom of the media and expression, the international-law right of self-determination, the law of international organisations, and legal questions relating to neutrality and foreign policy.

Woker, Daniel, Dr iur., is a former Swiss ambassador, serving in the Gulf region (Kuwait, Bahrain, Qatar), then in Singapore, and finally in Australia. Before that he was the first Director of the Geneva Centre for Security Policy (GCSP). After leaving the Swiss Federal Department of Foreign Affairs (EDA), he taught at the University of St Gallen (HSG). He works as an independent publicist. Together with Philippe Welti, former ambassador to India and Iran, he founded *Share-an-Ambassador/Geopolitics from Experts*, a company offering teaching and advisory services.
