**Abel, Johanna**, research fellow in the project *Iconic Presence. Images in Religions* at the Center for Literary and Cultural Research (Berlin, Germany). PhD in Romance Studies on the narrativization of body knowledge in 19th-century travel accounts by European women writers on the Hispanic Caribbean. Her monograph was published in 2015 as *Transatlantisches KörperDenken: Reisende Autorinnen des 19. Jahrhunderts in der hispanophonen Karibik* (Berlin: tranvía).

**Damir-Geilsdorf, Sabine**, professor of Islamic Studies at the University of Cologne, Germany. Her areas of research include political Islam, transformations of religious concepts, reform Islam, Salafism in Germany, popular culture in the Middle East. She is the author of *Die ‚nakba‘ erinnern. Palästinensische Narrative des ersten arabisch-israelischen Kriegs 1948*. (Göttingen: Reichert, 2008) and *Herrschaft und Gesellschaft. **Gómez-Popescu, Liliana**, associate professor at the University of Zurich and director of the research project *Transcultural Workspaces* at the University of St. Gallen, Switzerland. Her main research fields are Ibero-American literatures and cultures. She edited the Special Issue “History through Photography” *Estudios Interdisciplinarios de América Latina y el Caribe* (2015, 26: 2), with Carlos Rincón, and is the author of *Lo Urbano. Teorías culturales y políticas de la ciudad en América Latina* (Pittsburgh 2014).

**Hutson, Elaine**, professor of history at Huston-Tillotson University (Austin, Texas), with a research focus on African and Middle East history, in particular slavery and gender in Islamic societies. Her main publications include “Enslavement and Manumission of Africans and Yemenis in Saudi Arabia, 1926-

1938” in *Critique: Critical Middle Eastern Studies*, and “African Sufi Women and Ritual Change” in the *Journal of Ritual Studies*.

**Lindner, Ulrike**, professor of modern history at the University of Cologne, Germany. Areas of research include European colonialism in Africa, comparative imperial history and social policy in late colonial Africa. She is the author of *Koloniale Begegnungen: Deutschland und Großbritannien als Imperialmächte in Afrika* (Frankfurt a.M.: Campus, 2014) and of “The Transfer of European Social Policy Concepts to Tropical Africa, 1900-50: The Example of Maternal and Child Welfare” in *The Journal of Global History* (2014).

**Müller, Gesine**, professor of Romance Studies at the University of Cologne, Germany. Her areas of research include literatures of French and Spanish Romanticism, Latin American contemporary literature, Latin American culture theory, literatures of the Caribbean, literary transfer processes and transcultural studies. Her current research includes the ERC-funded project “Reading Global: Constructions of World Literature and Latin America”. She is the author of *Die koloniale Karibik. Transferprozesse in frankophonen und hispanophonen Literaturen* (Berlin: De Gruyter).

**Tappe, Oliver**, Senior Researcher at the Global South Studies Center, University of Cologne. His main field of research is the historical anthropology of upland Southeast Asia. He is co-editor of the volume *Interactions with a Violent Past* (with Vatthana Pholsena, National University of Singapore Press, 2013), and editor of the special issue “Frictions and Fictions – Intercultural Encounters and Frontier Imaginaries in Upland Southeast Asia” in *The Asia Pacific Journal of Anthropology* (2015).

**Van Rossum, Matthias**, Senior Researcher at the International Institute of Social History (IISH) in Amsterdam. NWO Veni Research Grant (2016-2019) for the research project *Between local debts and global markets* on the history of slavery and slave trade in early modern (Dutch) Asia. He published Dutch monographs on the history of slavery in Asia (*Kleurrijke Tragiek*, 2015), on Asian and Europeans sailors working for the Dutch East India Company (*Werkers van de wereld*, 2014) and on sailors’ unions and interracial relations on the Dutch merchant fleet in the 20th century (*Hand aan Hand*, 2009).
