Peer Review Policy

Submissions may be in English or German and should be sent by email (WORD documents preferred) to the editors. Submissions must be original contributions and should not be under consideration for any other journal or scholarly anthology at the same time.

Articles should include an abstract including the title of the paper, name(s) and affiliation(s) of the author(s), and keywords (3–5 keywords organized alphabetically); length of abstract: 150–200words. Submitted articles may range from 4000 to 8000words; well-founded exceptions are possible.

When a new submission is received, it is assigned to the section editor and one of the three executive editors, who read the paper, consult and decide whether it should be sent for peer review based on the editorial criteria of andererseits of novelty, soundness, and scholarly significance.

If the decision is not to send a submission for review, the section editor will contact the author(s) with that decision.

If the editors decide to accept a submission for peer review, they will contact two scholars with relevant expertise for each submission. Referees are not identified to the authors, except in cases when a referee particularly requests this.

Referees submit brief reports to the section editor, usually within eight weeks – often sooner. The editorial team discusses the reports and makes the final decision.

Finally, the peer reviewed section editor contacts the author(s) with one of the following decisions: A – Accepted without changes. B – Accepted pending minor revisions. C – Invitation to resubmit pending significant revisions. D – Not accepted for publication.
