

## 7. Conclusion

There is no doubt that independent churches are increasingly emerging in different parts of the world, particularly in Africa where there has been a strong need to indigenise Christianity. Several Christian sects in Africa today can be broadly referred to as independent churches. Classification schemes such as the DDC, LCC and UDC have, however, not made provision to accommodate books on independent churches in Africa in particular and the world in general. They only made provision for independent churches in the United States. The paper recommends that provision be made for classifying books and other information media on independent churches in Africa as a solution to the problem.

## Reports and Communications

### INTERCOCTA Workshop

A pre-congress workshop on Problems of Social Science Terminology will be held on August 24, 1993 (the day preceding the TKE-Congress) in Cologne, Germany. The focus of papers and discussions will be on recent developments in the computerization of the printed draft for a pilot INTERCOCTA glossary for researchers on *Ethnicity* which was distributed in 1985. A hypertext version is now available, and the material has also been prepared in an MTX/TERMEX database. A French draft prepared by Eric de Grolier, in Paris, is also being computerized and a multi-lingual version in French and English will be produced. Concurrently, a German text is being prepared in Vienna with the expectation that a tri-lingual version can eventually be generated. In each case, the nearest conceptual equivalent for each concept can be rapidly retrieved so as to make comparisons and establish the best terminological equivalence.

The theoretical and practical advantages of different computer programs for the purposes of this exercise and of any future projects in which methods of descriptive (rather than normative) terminology are used, may also be discussed at the workshop. A tutorial explaining the hypertext approach, plus the HYPERREZ and HYPLUS programs used in the demonstration project, are now available on a diskette for interactive use with text editors in any IBM-compatible personal computer with a hard disk. It is expected that the data will also soon be available free of charge online from a bulletin board, using a LISTSERV system.

Consultations have been launched with UNESCO and the International Commission for Social Science Information and Documentation (ICSSD) with a view to linking computerized conceptual knowledge bases for the social sciences with parallel modules containing current bibliographic data and information about ongoing research, in selected subject fields. The pilot project for "Ethnicity Research" provides a basis for experimentation which may, subsequently, be embraced by organized groups of specialists working on any other selected theme of subject area.

The INTERCOCTA project, which is sponsored by the International Social Science Council at UNESCO, as agent for all the global disciplinary associations in the social sciences, has been able with support from UNESCO, to experiment with the methodology required to produce modules containing terminological and bibliographic information about the basic works and theoretical frameworks in which the key concepts of a given subject field have evolved. When users are ultimately able to load this data into their personal computers for interactive use with information about recent publications and ongoing research, they will acquire a powerful and low-cost know-

lege base to facilitate their research in any subject field. The pilot project for "Ethnicity" (including nationality conflicts) focusses on a major problem domain which now attracts the attention of researchers in every social science discipline throughout the world who are using a wide variety of national languages. A new project on the "Human Dimensions of Global Change" is currently being planned. Other themes will emerge in the future, depending on the interest of organized research groups and the success of the methodology now being developed through the INTERCOCTA project. The workshop in Cologne will consider some practical implications of this project as well as the theoretical and methodological issues concerning terminological work that occur in fields where the acceptance of "preferred terms" cannot be secured. ### New Terminology Interchange Format

The Localisation Industry Standards Association (LISA) has announced the publication of the LISA Terminology Interchange Format. This new specification will enable companies to exchange terminology databases between various hard- and software platforms, thereby improving the quality and speed of multilingual document production and the product localisation process. The LISA format is compatible with existing standards, such as SGML, ISO 639/1139, and the Text Encoding Initiative, and is fully supported by the International Standards Organization (ISO).

The LISA Management Board is comprised of Apple Computer Europe, Alpnat Inc., Berlitz International, DEC/International Engineering, Hewlett-Packard Europe, IBM/European Language Services, Microsoft/International Product Group, NCR France, Oracle Europe, Rank Xerox Language Centre, Sequent Computer Systems Europe, and Softrans International. ## The LIDO Bibliographic Database and Mailserver for AI Literature

A unique bibliographic database on publications in the field of Artificial Intelligence has been established at the University of Saarbrücken in 1989 which means it is now in operation for three years. It covers the whole field of Artificial Intelligence and Computational Linguistics. Relevant work from adjacent areas (e.g. Linguistics, Psychology, Philosophy, Logic, and Theoretical Computer Science) is also considered. It is accessible by everybody who has access to electronic mail. The LIDO Bibliographic Mailserver going with the database allows for the retrieval of bibliographic information on AI-related publications via electronic mail. The references are returned in LaTeX (Bibtex) format or in a refer-like format.

As of Jan.1993, nearly 28,000 references have been entered into the database, with an annual increase of 20%. About 4500 bibliographic requests from 40 countries are currently handled each year. Since 1991, the LIDO bibliographic mailserver has been included in the NSF Internet Resource Guide.

Queries to the bibliographic database may refer to the author name(s), the title, and the year of publication. Substring search and regular expressions (egrep) are possible. Global keywords or classification hierarchies cannot be accessed. Users who already have a certain overview of a field will thus probably profit more from the LIDO Mailserver than novices familiarizing themselves with a new area.

Only references physically available on the campus are entered into the LIDO database. It is therefore necessary that authors send a free copy of each new book or journal article pertaining to the field of Artificial Intelligence to the following address: Prof. Dr. Alfred Kobsa, LIDO Biblioware Systems, Informationswissenschaft, Universität Konstanz, D-7750 Konstanz.

Maintenance and the update of the bibliographic service is fully funded by the Department of Computer Science, University of Saarbrücken. ## Electronic Index for the Encyclopedia Britannica

A CD-ROM electronic information indexing system for the Encyclopedia Britannica will be available in September 1992. Users will find a 100-fold increase in the number of references to individual topics in the 32-volume encyclopedia. The system will accept natural-language reader questions and provide relevance-ranked lists of articles that address the user's question. In most cases, Britannica claims, the system can generate the list of article references in less than 30 seconds, although complex questions may take longer. References are to volume numbers, page numbers, and specific page quadrants where the information can be found. Users of personal computers can print the list of references for a hard-copy record. The index will be updated annually to correspond with each year's printing of the encyclopedia.

The technology that makes the index work is SmarTrieve, Britannica's proprietary software engine. It runs on all IBM-compatible, DOS-based PCs with a CD-ROM drive.

Added components of the index include a "People, Places, and Things" feature that offers access to topics by categories, and such research tools as a dictionary based on Merriam-Webster's *Ninth New Collegiate Dictionary* is also included. ## OCLC Subject Headings Improvement Project

OCLC's ongoing program of improving the quality of subject headings in the Online Union Catalog moves into its third phase in 1992 after correcting over 1 million subject headings in Phase 2. Phase 2 of the project, which ran from November 1991 to February 1992, examined and corrected the Library of Congress topical and geographic subject headings in Online Union Catalog records. Phase 3 will convert obsolete headings to current forms and reduce the "split file" problem materials on the same subject file in more than one place. It will examine and correct topical and geographic subject headings as well as personal names, corporate names, conference or meeting names and uniform titles. Seven types of corrections will be made: obsolesces, style, coding, typographical errors, inversions, abbreviations, and manual corrections (invalid forms reviewed by quality control staff and matched to correct forms.
