Five years is too long to work on something alone. This book has benefited from valuable inspiration, input and refinements from a group of mentors, colleagues and loved ones.

My first supervisor, Christopher Daase, helped me find the right conceptual key to open up the necessary analytical scope for an innovative resistance analysis, while remaining theoretically sound. His advice was crucial in helping me to integrate the work into the existing research corpus and to relate it to the overarching issues of our discipline, thus ensuring that I did not lose sight of the scientific objective and investigative added value of my study.

Jochen von Bernstorff was the one who convinced me that my thoughts on the subject could have sufficient academic relevance and substance for a doctoral thesis. Our early discussions, before I made the decision to pursue a doctorate, sparked my interest in critical and post-colonial perspectives and boosted my confidence to take on a legal-sociological approach. Throughout the process, he kept my mind alert to the strategic instrumentalization of international law by nuclear rulers and anti-colonial resisters.

Without Andreas Hasenclever, his scrutinizing review of the research design and drafts and his justifiably challenging questions, I would have had significantly less chance of prevailing in the competition for a doctoral position and ultimately qualifying for a successful degree. Time and again, his roguish skepticism sharpened my analytical eye, for example, to identify the “subversive” character of the Humanitarian Initiative, enabling me to plow through hard empirical ground with precise arguments.

Among the many esteemed colleagues at the Peace Research Institute Frankfurt (PRIF) who have dealt with my research question and methodology in colloquia, workshops and bilateral discussions, and who have discussed with me the consistency of my analysis or the guidelines and evaluation tools for the interviews, I would particularly like to mention Ben Christian, Antonia Witt and Felix Bethke. Stefan Kroll supported me with tips for communicative and professional introductory and concluding chapters as well as with the publication process.
