Zhyldyz Bakirova is deputy director of the Republican Center of Narcology in Bishkek, Kyrgyzstan and PhD student at Bishkek State University named after Karasayev. She is a psychiatrist by training and participated in a number of international research projects, including the CADAP annual report and the study “Needs and gaps in treatment and rehabilitation for people who use drugs in selected countries of EECA”. Zhyldyz is an expert of the National Group of developers and pilots of the United Nations Office on Drugs and Crime (UNODC) quality assurance tools and has published articles on opioid overdose prevention and drug rehabilitation programmes in the Kyrgyz Republic. Her research interests include social work in the treatment continuum, drug treatment and psychoactive substances.

Alla Bessonova is the chairwoman of the Eurasian Women’s AIDS Network and a Master student at the Faculty of Psychology at Bishkek State University named after Karasayev. She has participated in a number of gender research projects, including the women-led gender assessment “How countries address barriers to HIV services for women living with HIV, sex workers and women who use drugs”. Alla is an expert in the regional drug policy group of the Eurasian Harm Reduction Association (EHRA). Her professional interests include advocating for the use and application of scientific approaches in drug treatment and working with people who use drugs.

Azizbek Boltaev, M.D., is a psychiatrist with 20 years of clinical and research experience in the field of addiction medicine, mental health and HIV. Azizbek Boltaev holds a position as director of the Human Research and Development Center in Bukhara, Uzbekistan. He participated in the development and management of programs aimed at treating people who use drugs in Central Asia and Eastern Europe. As an advisor to UKAID and PEPFAR-funded programs, he was actively engaged in the initiation and scaling-up of opioid substitution therapy in Kazakhstan, Kyrgyzstan, and Tajikistan. Dr. Boltaev served as technical expert for various international bodies including the UN Theme Group on injecting drug use (Austria), the Steering Committee of the Eurasian Harm Reduction Network (EHRA) (Lithuania), the Technical Review Panel of the Global Fund to fight AIDS,

He regularly consults the World Health Organization (WHO), the United Nations on Drugs and Crime (UNODC), the United States Agency for International Development (USAID) and the Centers for Disease Control and Prevention (CDC). Azizbek Boltaev continues his daily clinical practice in Bukhara and sees patients with mental and substance use disorders.

Daniel Deimel is a social worker (Dipl.), addiction therapist (M.Sc.), health scientist (PhD), supervisor at the Deutsche Gesellschaft für Supervision und Coaching e.V. (DGStV) and Research Professor of Health Promotion and Prevention at the Technische Hochschule Nuremberg, University of Applied Sciences, Faculty of Social Sciences. He is also a visiting researcher at the University of Duisburg-Essen, Medical Faculty and LVR-Hospital Essen, Department of Addictive Behavior and Addiction Medicine. His work focuses on HIV and addiction research in the social sciences, project development and evaluation expertise, particularly in health promotion for vulnerable and marginalized groups, drug and HIV/AIDS services and evidence-based social work. He is part of the ESCAPE drug analysis project of the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) and a member of the Correlation European Harm Reduction Network (C-EHRN).

Jiang Du is a psychiatrist and research professor at the Shanghai Mental Health Centre. She holds a PhD and serves as a supervisor for doctoral and master students. Jiang Du has been engaged in basic and clinical research related to addiction for over ten years. She has been working on the assessment and clinical intervention of high-risk behaviors related to drugs for a long time, as well as on the research regarding the biological mechanisms of brain cognitive function changes caused by synthetic drugs. She has accumulated rich experience in the field of addiction research and evaluation. From 2007 to 2008, and in 2013, she received funding from the National Institutes of Health to visit and study at the University of California, Los Angeles. She studied under the guidance of professor Hser Yih-ing and was engaged in a long-term follow-up research and related statistical analysis of substance addiction patients.

Tynchtyk Estebes Uulu is a PhD student at the Department of Sociology and Political and Legal Disciplines of the Faculty of Social Psychology at Bishkek State University. He received a master's degree from the OSCE Academy in Bishkek, majoring in "Politics and Security (Central Asia)". His

current research focuses on social work, NGOs, the probation system, drug addiction, drug trafficking and sustainable development.

Meryem Grabski is a postdoctoral researcher at the Frankfurt University of Applied Sciences. She completed her PhD on the role of craving in tobacco addiction and potential treatments for it at the University of Bristol in 2018. Before joining the SOLID project, she worked as a research associate at University College London and the University of Exeter in the UK. Here, she worked on a survey-based study investigating the substance use of young Europeans in the nightlife scene as well as a clinical trial investigating the effectiveness of ketamine as a treatment for problematic alcohol use. Her research interests include drug use and addiction as well as the investigation of novel treatment methods. She has been using different research methods to this end such as eye-tracking, pharmacological manipulations, online surveys and data collection using mobile phones (ecological momentary assessments).

Sandugash Ismagulova is a social work specialist in Kyzylorda city polyclinic No. 6. She is also a branch manager at the National Alliance of Professional Social Workers of Kazakhstan, for the city of Kyzylorda and Kyzylorda region.

Medet Kudabekov is a PhD student at the Department of Sociology and Social Work of the Eurasian National University named after L.N. Gumilyov in Astana, Kazakhstan. His main research interests include the professionalization of social work in the framework of the modernization of the social service system.

Ingo Ilja Michels, PhD, is sociologist and advisor for treatment of drug dependence. Since 2010, he was Project Leader of the EU Central Asia Drug Action Programme (CADAP), since 2020 he is the International Scientific Coordinator of the SOLID project at the Frankfurt University of Applied Sciences. He worked in a psychiatric clinic with drug dependent heroin users, as Head of the Drugs and Prison projects department of the German AIDS-Hilfe in Berlin, as Drug Commissioner of the Federal State of Bremen in northern Germany, and as Head of the Office of the Federal Drug Commissioner within the Federal Ministry of Health in Berlin. He is freelance advisor for drug services in PR China in Beijing and Shanghai and Guest Professor at the Department of Sociology/Social Work of the East China University of Science and Technology (ECUST), Shanghai.

He is author of several articles on prevention and treatment of drug dependents and on drug policy in International Journals on Substance Use.

Dalida Mukasheva is PhD student at the Department of Sociology and Social work of the Eurasian National University, named after L. Gumilyov. Her main research topics include health and social welfare in prisons, the situation of women with HIV and the professional roles of social workers. Before joining the SOLID Project, Dalida worked for development agencies in Kazakhstan. She has experience in education, science and research, and is member of the National Alliance of Professional Social Workers of Kazakhstan.

Nurgul Musaeva, PhD, is Associate Professor of Psychology at the Bishkek State University named after Karasayev. She holds a PhD in Social Philosophy. She is member of the Association of Social Workers of the Kyrgyz Republic and one of the developers of the State Educational Standards in the direction of “Social Work” and “Psychology” at Master’s and Bachelor’s level. Since 2020, she is National Scientific Coordinator of the SOLID Exceed SOLID project Kyrgyzstan, which is funded by the German Academic Exchange Service (DAAD). She is the author of more than 30 scientific articles, three books devoted to the philosophy of social work, the development of psychological thoughts among the Kyrgyz people and social psychology. Currently, she is studying the issues of training specialists to work with vulnerable population groups such as people living with HIV, people in prison and people using drugs.

Sona Orbelyan is Programme Manager for HIV and TB Programme at UNDP Tajikistan. She has been working as public health practitioner in programs and projects in HIV and TB with different donors and development partners in EECA region for 20 years.
