Her recent publications include *Critical Neurodiversity Studies: Divergent Textualities in Literature and Culture*, London 2025, co-edited with Louise Creechan and Anna Stenning, in which she also contributed the chapter »Humorous Failures: Neurodivergence in Scandinavian Young Adult Fiction«. Earlier work includes an exploration of vulnerability as a critical concept for rethinking disability in contemporary Nordic literature (Cham 2020).
