*Hannah Broecker* is a researcher of International Relations at Marburg University. The preliminary title of her dissertation is: 'Securitization as hegemonic discourse formation' and works on the embedding of the securitization-model within a further discourse and hegemony theory. Hannah Broecker studied the Bachelor of Sociology and International Relations at the Aston University in Birmingham UK. In 2012, she finished her masters' degree of International Security Studies at Warwick University. Her researches are focussed on military interventions, concepts of statehood and the social construction of security. 2012 to 2013 Hannah Broecker was project member of the 'Academic Peace Orchestra' at the "Hessische Stiftung für Friedens- und Konfliktforschung". During her 5-month internships in 2009 at the Friedrich-Ebert-Stiftung in Nigeria (Abuja) and at the African Development Bank in Uganda (Kampala) Hannah Broecker collected experiences in the field of development work.

*Carola Dietze*, Privatdozent, is currently a German Research Association Heisenberg fellow and has been a researcher in the history department of Justus Liebig University Giessen since 2010. Previously, she has been a visiting professor for modern and contemporary history at Ludwig Maximilians University Munich and Technische Universität Carolo-Wilhelmina Braunschweig (Brunswick) as well as a fellow at the German Historical Institute in Washington, DC and the Netherlands Institute for Advanced Study in the Humanities and Social Sciences, Wassenaar. Carola Dietze was a leading researcher in the Subproject B04 — "Security of the State and Security from the State in Europe, Russia and the United States in the 19th Century" at the DFG Collaborative Research Centre/Transregio 138 „Dynamics of Security. Types of Securitization from a Historical Perspective“. She has published several articles on assassination attempts, terrorism, and security in the 19th century. Her most recent book *Die Erfindung des Terrorismus in Europa, Russland und den USA 1858-1866* (Hamburg: Hamburger Edition 2016) examines the emergence of terrorism in 19th century Europe, Russia and the United States. An English translation of the book is prepared by Verso in London. Together with Iwan Iwanov and Nikolaus Katzer, Dietze is currently editing a volume on *Dynamics of Se-*

*curity in Russia in the Age of Revolution and Restauration 1790-1840*, which will appear in a publication series of the German Historical Institute in Moscow.

*Sebastian Haus* has studied modern history, political science and sociology in Marburg and Paris and is currently a research assistant at the Department of Modern History, University of Marburg. He works on his PhD thesis on the history of HIV/AIDS prevention in Germany, 1981-1995, which is part of the subproject C01 “advanced security. Changes in statehood since 1970”. *Maria Ketzmerick* is research associate at the Centre for Conflict Studies and the collaborative research centre „Dynamics of Security“ (SFB 138) at Philipps University Marburg. Therein she is focusing her PhD on transitional processes with a focus on dynamics of de/securitization, postcolonial/decolonial theories and external state- and peacebuilding missions. Prior to that she studied Political Sciences and (international) Law, with a Master in „Global Studies“ (African studies in combination with international relations) at Westfälische Wilhelms-Universität Münster, IEP Lyon, Roskilde University, and Leipzig University. *Regina Kreide* is a professor of Political and Social Theory and the History of Ideas at the Justus Liebig University in Giessen, Germany. She studied Sociology, Political Science, and Philosophy at the University of Cologne, Goethe University in Frankfurt and at Columbia University in New York. In 2001 – 2008 she worked as an assistant professor and senior lecturer of Social Sciences at Goethe University in Frankfurt. She also taught as a Visiting Professor at the New School for Social Research in New York (2009), the Universidad de Antioquia Medellin, the UAM Izta-palapa, Mexico City, Mexico, and was a visiting professor at the University of Washington Seattle. She is one of the co-speakers of the Collaborative Research Center "Dynamics of Security" (SFB). She has published widely in international journals on global justice, human rights, international law, democracy, security, and European minorities. Her most recent book publications include the *Habermas-Handbook*, together with Hauke Brunkhorst and Cristina Lafont, Columbia UP 2017; *Transformation of Democracy: Crisis, Protest, and Legitimation*, ed. with R. Celikates and T. Wesche, with Rowman&Littlefield, 2015; *The Repressed Democracy* 2016

(in German), and *Politics of Security*, with van Baar and Ivasiuc, Palgrave, forthcoming 2017. Her book *Global (In-)Justice?* (in German) will appear 2018.

*Christine Krüger* is a research assistant at the SFB “Dynamics of Security”. In 2005 she graduated at the University of Tübingen with her multiple award-winning work on German Jews in the war of 1870/71. Christine Krüger was qualified as a university lecturer at the University of Oldenburg in 2015. In 2008 and 2009 she worked as Feodor-Lynen-Fellow of the Alexander-von-Humboldt Foundation at the Oxford University. She was fellow at the Institute for Advanced Studies in 2012. *Andreas Langenohl* is professor of sociology with a focus on general comparative studies at Justus Liebig University Giessen. He held research and teaching positions at Konstanz University and Ghent University. His research foci include economic sociology and the sociology of finance, social and cultural theory, transnationalism, and the epistemology of the social sciences and economics. For his monograph *Finanzmarkt und Temporalität: Imaginäre Zeit und die kulturelle Repräsentation der Gesellschaft* (Stuttgart: Lucius & Lucius, 2007) he received the Karl-Polanyi-Award of the research stream Economic Sociology in the German Sociological Association. More recent publications include “Securities markets and political securitization: The case of the sovereign debt crisis in the Eurozone”, in *Security Dialogue* 48(2), 2017, 131-148, and *Town Twinning, Transnational Connections, and Trans-local Citizenship Practices in Europe* (New York/Basingstoke: Palgrave Macmillan, 2015).

*Friedrich Lenger*, chair for medieval and modern history at Giessen University since 1999, studied history, sociology, political sciences and cultural anthropology at the universities of Michigan (Ann Arbor), Bielefeld and Düsseldorf; MA (Ann Arbor, MI 1979), Dr. phil. (Düsseldorf 1985), Dr. phil. habil. (Tübingen 1993). From 1985 to 1993 he worked as lecturer and assistant professor at Tübingen University. Prof. Dr. Friedrich Lenger was associate professor at Erlangen University from 1995 to 1999 and visiting professor at St. Antony’s College, Oxford in 1997/98 and at George-

town University, Washington, DC in 2001/02. He directs the project C02 within the „SFB“ and is a member of its conceptual working group 4 (The power of security). His relevant publications include *European Cities in the Modern Era, 1850-1914*, Brill: Leiden/Boston 2012 and as editor: *Kollektive Gewalt in der Stadt. Europa 1890-1939*, Oldenbourg: Munich 2013.

*Thilo Marauhn* is Professor of Public Law and International Law at Justus Liebig University Giessen, Germany, and head of the newly established International Law Research Group of the Peace Research Institute Frankfurt. Furthermore, he also holds a permanent visiting position at the University of Lucerne, Switzerland. He chairs the German National Committee on International Humanitarian Law, is a member of the Advisory Board on United Nations Issues of the German Foreign Office and President of the International Humanitarian Fact-Finding Commission. He has held visiting professorships at the Universities of Bergen, Madison (Wisconsin), Rovaniemi, Tromsø and California Western School of Law, San Diego. Among the various externally funded research projects is “UN policing – legal basis, status and directives on the use of force” (funded by German Foundation of Peace Research). He has published widely in pertinent journals. His most recent book publications include *Lehre des Internationalen Rechts – Zeitgemäß?! 2017* (ed. with S. Hobe), *Legal transformation in Northern Africa and South Sudan*, 2015 (ed. with H. Elliesie), and *Transboundary governance of biodiversity*, 2014 (ed. with L. Kotzé), ‘Sanctions and the Protection of Human Rights’, 2016 (with I. Stegmiller), and on ‘The Prohibition of Chemical Weapons’, 2016.

*Marie-Christin Stenzel* is a PhD candidate in international law at the faculty of law of Justus Liebig University Giessen, Germany. She studied law at the universities of Giessen and Montpellier, France.
