Hülya ADAK received a Ph.D. in Comparative Literature from the University of Chicago. Since 2001, she has been working as Assistant Professor in the Cultural Studies Program at Sabancı University, Istanbul. Her research and publications focus on gender and sexuality, national myths, theories of autobiography, and the novel. She is currently working on her book, *National Myths of Modern Turkey*.

Olca AKYILDIZ is about to finish her Ph.D. thesis, *Occidentalism in Turkish Literature*, for the Comparative Literature Department of Tübingen University. Since 2001 she has been teaching as an instructor at the Department of Turkish Language and Literature at Boğaziçi University. Her research focuses on the question of the “Other” in different cultures and literatures, travel writing, gender, and sexuality in literature.

Catharina DUFFT, M.A., has been doing doctoral studies in Turkish Studies and Comparative Literature at Free University Berlin on “Istanbul in Orhan Pamuk’s Works” since 2002. From 2003-2005 she held a research fellowship at the Orient-Institut Istanbul, and since 2005 she has been a lecturer at Free University Berlin. She has published several articles on Turkish, German, and Arabic art and literature.

Susanne ENDERWITZ, Professor for Islamic and Arabic Studies, University of Heidelberg. Her main fields of research are classical and modern Arabic literature.

Her publications include *Liebe als Beruf. al-'Abbas b.al-Ahnaf (gest. Um 807) und das Ghazal* (Beirut 1995); *Unsere Situation schuf unsere Erinnerungen. Palästinensische Autobiographien zwischen 1967 und 2000* (Wiesbaden 2002), and numerous articles on literary history, autobiography, and cultural history.

Nüket ESEN received her B.A. in English Literature and M.A. in Sociology from Boğaziçi University, Istanbul, and her Ph.D. in Turkish Literature from Marmara University. She specializes in the Turkish novel, literary theory, narratology, and Ahmet Midhat and has a number of published books and many published articles on Turkish literature. She is a full professor at the Department of Turkish Language and Literature at Boğaziçi University.

Özkan EZLI, M.A., studied New German Literature, Sociology, and Islamic sciences in Freiburg (Germany). From 2002-2003 he conducted a study on “Buch- und Medienpraxis” at the Johann Wolfgang Goethe University in Frankfurt. Since July 2004 he has held a scholarship for graduated studies from the Studienstiftung des deutschen Volkes for a Ph.D. study entitled, “Culture analytical observations of German, Turkish, and Arabic autobiographies of the twentieth century.”

Erika GLASSEN was born 1934 in Malchow/Mecklenburg. She studied German Literature and Islamic Sciences in Freiburg and Basel from 1955-1968, received her Ph.D. from Freiburg in 1968 for her study entitled "Die frühen Sa-fawiden" and earned her post-doctoral qualification from Freiburg in 1977 for her study "Der mittlere Weg. Studien zur Religiosität und Religionspolitik der späteren Abbasiden-Zeit." From 1981-1983, she was a researcher at the Orient-Institut Beirut. Later, she became apl. Prof. at Freiburg University and was from 1989-1994 the Director of the Orient-Institut der Deutschen Morgenländischen Gesellschaft in Beirut and Istanbul. Currently the editor of the *Die Türkische Bibliothek* (Turkish Library), her major research interests are: History and Literature of the Islamic countries (especially of the Iranians and Turks) in the Late Medieval Near East, Autobiography, and Modern Turkish Literature.

Stephan GUTH received his M.A. (1987) and Ph.D. (1992) in Middle Eastern and Islamic Studies after having attended lectures at the universities of Bonn, Cairo, and Tübingen. He wrote his M.A. and Ph.D. theses on modern Egyptian prose, and was Research Fellow of the Orient-Institut der Deutschen Morgenländischen Gesellschaft in Istanbul and Beirut in 1992-1996. Since 1996 he has been Lecturer for Modern Literatures of the Near and Middle East at University of Berne. Guth specializes in Comparative Literature, cf. post-doctoral thesis (*Habilitation: an integral history of the Arabic and Turkish novel* (Bern 2003)).

Herrad HESELHAUS majored in German Literature after a broad liberal arts education at several universities in and outside of Germany. After a doctoral thesis on a comparative literature problem, she taught German Literature and Comparative Literature at Ludwig-Maximilians-University München (Germany) and Eberhard-Karls-University Tübingen (Germany), respectively. She has been a visiting professor in Comparative Culture Studies at Tsukuba University (Japan), where she is now professor for German Literature. In recent years her research has been focused on the representation of old age in literature and art and on the analysis of philosophical, scientific, and literary discourses on aging.

Sibel IRZIK received her Ph.D. in comparative literature from Indiana University and taught English and comparative literature in the English Department of Bogazici University before joining the Cultural Studies Program in Sabanci University in 2005. She is the author of *Deconstruction and the Politics of Criticism*, and the co-editor of *Relocating the Fault Lines: Turkey beyond the East-West Divide*, a special issue of *The South Atlantic Quarterly*. She has also edited a selection of Mikhail Bakhtin's writings and a collection of articles on gender and literature in Turkish. Her recent publications include articles on the modern Turkish novel, literary theory, and post-colonial literature. Most recently, her article on Orhan Pamuk's Istanbul as depicted in *The Black Book* appeared in *The Novel*, edited by Franco Moretti.

Gabriele JANCKE is a historian and member of the DFG-research group, “Selbstzeugnisse in transkultureller Perspektive/Self-Narratives in Transcultural Perspective” at the Free University of Berlin. She specializes in early modern history, gender history, and historical anthropology, and her fields of research are self-narratives in transcultural perspective, scholars’ culture, patronage, Jewish history, and convents. Currently she is working on a larger study about early modern hospitality. Among her publications are *Autobiographie als soziale Praxis. Beziehungskonzepte in Selbstzeugnissen des 15. und 16. Jahrhunderts im deutschsprachigen Raum* (Selbstzeugnisse der Neuzeit 10; Köln/Weimar/Wien: Böhlau 2002), and she is co-editor (with Claudia Ulbrich) of *Vom Individuum zur Person. Neue Konzepte im Spannungsfeld zwischen Autobiographietheorie und Selbstzeugnisforschung* (Querelles 10; Göttingen 2005). She is also the author of many articles on early modern autobiographical writing, focusing on contexts as well as on methodological and theoretical issues.

Halim KARA received his Ph.D. from Indiana University in 2000. He has been teaching modern Turkish literature in the Turkish Language and Literature Department of Boğaziçi University, Istanbul, since 2001. Over the past several years, he has produced scholarly works on modern Turkish and Uzbek literature. He is currently working on various aspects of modern Turkish literature, such as the question of Occidentalism and Orientalism, identity, and the Other.

Born and raised in Tehran, Farzaneh MILANI attended French primary and secondary schools. She earned her BA in French Literature in 1970 from California State University at Hayward. Transferring to the University of California in Los Angeles, she completed her graduate studies in Comparative Literature in 1979. Her dissertation, *Forugh Farrokhzad: A Feminist Perspective*, was a critical study of the poetry of a pioneering Iranian woman poet. Milani taught Persian Language and Literature at UCLA for four years before coming to the University of Virginia in 1986. Past president of the Association of Middle Eastern Women Studies in America, Milani was the recipient of Alumni Teaching Award in 1998. She is the author of *Veils and Words: The Emerging Voice of Iranian Women Writers* and *A Cup of Sin: Selected Poems of Simin Behbahani* (with Kaveh Safa). She has served as the guest editor of two special issues of *Nimeye Digar* on Simin Daneshvar and Simin Behbahani. Milani has written over 60 articles, book chapters, introductions, and afterwards in Persian and English and lectured at over 100 colleges and universities nationally and internationally. Her poems have been published in *Nimeye Digar*, *Par*, *Barrayand*, *Daneshju*, *Omid*, and *Avaye Portland*. Currently, she is Director of Studies in Women and Gender and Professor of Persian and Women Studies at the University of Virginia in Charlottesville. She teaches courses in Persian literature and cinema, Islam, and cross-cultural studies of women.

Angelika NEUWIRTH received her Dr. Phil. in Arab, Semitic and Classical Studies from Göttingen in 1972, and her Dr. Phil. Habil. in Arabic and Islamic Studies from München in 1977. She has held professorships at the University of Jordan, Amman, Ayn Shams University, Cairo, and the University of Bamberg. Since 1991 she has been Chair of Arabic Studies at the Freie Universität Berlin. From 1994 to 1999, she served as Director of the Orient-Institut der Deutschen Morgenländischen Gesellschaft in Beirut and Istanbul. Her main research areas are Qur'an and Qur'anic exegesis and classical and modern Arabic literature, and she is the author of major publications on modern Arabic poetry.

Börte SAGASTER, Dr. phil., studied Turcology, Islamic Studies, and New German Literature at the Universities of Freiburg i.Br. and Hamburg. Since the 1980s she has conducted research and authored publications on images of the "Other" in Modern Turkish Literature, biographies and autobiographies of Turkish women, and developments in Turkish literature. At present, she is an assistant professor in the Department of Turkish and Middle Eastern Studies at the University of Cyprus, Nicosia.

Dr. Derin TERZIOĞLU is an assistant professor in the Department of History at Boğaziçi University. Her research interests lie in early modern Ottoman intellectual and cultural history. She is currently preparing for publication a critical edition and English translation of the diary of the seventeenth century Ottoman Sufi, Niyazi-i Misri, as well as a monograph entitled, *Mysticism, messianism and politics in early modern Ottoman Empire: the worlds of Niyazi-i Misri*.
