Her recent publications concern social ontology, transgenerational actions, relationship between generations and problems of social justice, fostering the interdisciplinary research between philosophy, social sciences and law. She is co-editor of the international journal *Brill Research*

Perspectives in Art and Law and since 2020, she is the editor of *Rivista di Estetica*. As fellow at the Columbia University (2008–2009), Käte Hamburger Kolleg, University of Bonn (2015), ITMO University, Russia (2014) and Saint Petersburg State University (2015 and 2016), University of Nanjing and University of Wuhan (2019), she started several international collaborations with leading institutions in the field of the social ontology, cultural studies, political philosophy and philosophy of law, making LabOnt one of the leading European centre in the field of social ontology. After his studies in law and art history in Bonn, Geneva and New York, he obtained an LL.M.-degree from New York University School of Law (1983) and his Ph.D. degree (1990) as well as his habilitation (2000) at the University of Munich. Johannes Eichenhofer is a private lecturer (“Privatdozent”), currently representing the Chair for Public Law at the law faculty of the University of Bielefeld, Germany. His research and teaching activities focus mainly on fundamental and human rights, especially in the areas of migration and integration, as well as privacy and data protection. He studied law at the Freie Universität Berlin and the Humboldt Universität zu Berlin, as well as at the Università degli Studi di Siena (Italy). After obtaining his First Legal States Exam from in Berlin (2009), he wrote his dissertation on the *Concept and Conception on Integration in the German Integration Act*, which was published in 2013 by Nomos. In 2013, he also completed his legal Clerkship (2011–2013) at the Higher Regional Court in Berlin. He is also the director of “Scienza Nuova”, an institute of advanced studies – dedicated to Umberto Eco and uniting the University and the Polytechnic of Turin – aimed at planning a sustainable future, both from a cultural and from a political point of view. He wrote more than sixty books that have been translated into several languages. The last one is *Documanità. Filosofia del mondo nuovo* (Laterza 2021).

Christophe Geiger is Professor of Law at Luiss Guido Carli University, Rome. Previously, he taught at the Centre for International Intellectual Property Studies (CEIPI) of the University of Strasbourg (France), which he led as Director General and Director of the Research Department for 11 years. Europe (2013, in French); *Intellectual Property Law in a Globalized World* (with Caroline Rodà, 2014), *The Intellectual Property System in a Time of Change: European and International Perspectives* (2016), *Trade-Related International Intellectual Property Law: The TRIPS Agreement, Assessment and Perspectives* (2017, in French), *Computer-Implemented Inventions: Issues, Practices and Perspectives* (with Matthieu Dhenne, 2019, French/English) with LexisNexis; and *Penser le droit de la pensée: Mélanges in honor of Michel Vivant* (with J.-M. Bruguière, 2020), with Dalloz.

Werner Gephart is Senior Professor at the faculty of sociology at the University of Bonn, Germany. Besides being a legal scholar, sociologist he also is an artist. In 2014, alongside with German artist Amselm Kiefer, he was awarded an honorary doctorate in Philosophy by the University of Turin. In 2021–2022 he is Senior Fellow of the the Institut Michel Villey pour la culture du juridique et la philosophie du droit at the University of Paris II (Panthéon-Assas). Prof. Gephart is Founding Director and currently co-directing the Käte Hamburger Center for Advanced Study in the Humanities “Law as Culture”, in Bonn. He has held numerous visiting professorships, among others the Fulbright Distinguished Chair for German Studies at Washington University, St. Louis, a visiting professorship at the IDC (Herzlyia, Israel), numerous invitations as professor in Tunis, as well as the Chaire Alfred Grosser at SciencesPo, Paris. In 2019 he was appointed as President of the Jury Senior of the Institut Universitaire de France (IUF). He is the editor of the series “Law as Culture” (25 vol.) and co-editor of the volume “Recht” (“Law”), which is part of the Max Weber Gesamtausgabe (MWG I/22–3). His further publications are centered on the cultural analysis of law (*Recht als Kultur*, Klostermann 2006), the sociology of religion (*Religion und Identität*, 1998), and aesthetics (*Law and the arts* 2016). In addition, he is co-editor of the international journal *Art and Law, Brill Research Perspectives in Art and Law*. – As an artist he has held numerous exhibits in cities including Paris, Düsseldorf, Cologne, Bonn, St. Louis, Houston, Bloomington, Minneapolis, Tunis, New Delhi, and London. From 2016 to 2017, Werner Gephart was honorary artist at the Dickson Poon School of Law during his exhibition *Some Colours of the Law* at King’s College in London (Somerset House).

Olivia Hägle is a Ph.D. student at the Albert-Ludwigs University of Freiburg and a research assistant at the Institute of Information and Economic Law of the Karlsruhe Institute of Technology (KIT), Germany. After her High School graduation, she studied law at the University of Freiburg (2014–2019) with a focus on Intellectual Property Law and

He (co-)authored Houkes/Vermaas, *Technical Functions* (Dordrecht: Springer, 2010), and articles in peer-reviewed journals such as *The British Journal for the Philosophy of Science*, *Design Studies*, *The Monist*, *Philosophy of Science*, *Research Policy*, *Studies in History and Philosophy of Science* and *Synthese*.

Lisa Käde is a postdoctoral research assistant at the Center for Applied Legal Studies at the Karlsruhe Institute of Technology (KIT). She studied law in Freiburg and Ottawa as well as business IT (B.Sc., B.A. (hons.)) at the Baden-Wuerttemberg State University of Co-operative Education (DHBW) Stuttgart. He has been visiting professor in several universities and research centres around the globe. His work focuses on the semiotic study of cultures, with particular emphasis on religion and images; his ERC project bears on the meaning of the face in the digital era. Massimo Leone has single-authored fifteen books, (*Religious Conversion and Identity: The Semiotic Analysis of Texts*, London and New York: Routledge, 2004; *Saints and Signs: A Semiotic Reading of Conversion in Early Modern Catholicism*, Berlin and New York: Walter de Gruyter, 2010; *On Insignificance*, London and New York: Routledge, 2019; etc.), edited forty collective volumes, and published more than five hundred peer-reviewed articles in semiotics, visual studies, and religious studies. He is the chief editor of *Semiotica* (De Gruyter), the chief semiotics journal in the world, and of the SCOPUS journal *Lexia*, and editor of the book series *I Saggi di Lexia* (Rome: Aracne), Routledge/FACETS Advances in Face Studies and *Semiotics of Religion* (Berlin and Boston: Walter de Gruyter).

Lorenz Müller-Tamm is a Ph.D. candidate in legal studies at the Albrecht-Ludwig University in Freiburg, Germany. The topic of his doctoral thesis is on the legal issues of street photography. His main research focus is on the consequences of digitalisation on law, especially on copyright and IT law. He is co-founder and co-editor of the open access journal *Recht und Zugang* (*Law and Access, RuZ*).

Cosetta Saba is professor of *Film Analysis* and *Audiovisual Practices in Media Art* at the University of Udine where she is vice-coordinator of Ph.D. in "Storia dell'Arte, Cinema, Media Audiovisivi e Musica".
