**Michael Butter** is Professor of American Studies at the University of Tübingen. He is the author of *The Nature of Conspiracy Theories* (Polity, 2020) and co-editor of *Covid Conspiracy Theories in Global Perspective* (Routledge, 2023). He is the Principal Investigator of the ERC-funded project “Populism and Conspiracy Theory” and one of the PIs of the CHANSE Project “Researching Europe, Digitilisation, and Conspiracy Theories,” which seeks to produce a thick description of how the internet has affected conspiracy theories in different European regions and seeks to develop recommendations of stakeholders on the national and EU levels. In 2021 he was awarded the Tübingen Prize for Knowledge Communication.

**Jörn Dosch** holds the Chair of International Politics and Development Cooperation at the University of Rostock. He is also an Adjunct Professor at the Asia–Europe Institute, University of Malaya. Previous positions include Professor of International Relations at Monash University (Malaysia Campus) and Head of the Department of East Asian Studies, University of Leeds. His research focuses on politics and international relations in the Indo-Pacific region, the European Union’s foreign relations, US foreign policy as well as migration and development theory and practice. Jörn also regularly works as a Consultant for the EU’s development program and has evaluated several donor-funded projects in support of partner countries in Asia and Latin America. His publications in-

clude *The New Global Politics of the Asia Pacific*, 3rd edition, Routledge 2018 (with M. Connors and R. Davison).

**Daniela Gottschlich** was trained in political science and German literature. She is presently Professor for Sustainability and Social Design (“Gesellschaftsgestaltung”) at the Hochschule für Gesellschaftsgestaltung (hfgg) in Koblenz. Her research and teaching interests are sustainable development from a critical-emancipatory perspective, new economies, right-wing populism and socio-ecological transformation, and ways of democratizing social relations with nature. Her transdisciplinary and collaborative work is informed by feminist economics and political ecology. Together with Christine Katz she published “Caring with Nature/s: Zur transformativen Bedeutung von Care in More Than Human Worlds” (in: *gender<ed> thoughts. New Perspectives in Gender Research*. Working Paper Series, vol. 3, 2019). Together with Sarah Hackfort, Tobias Schmitt, and Uta von Winterfeld she co-edited the first German-language handbook on political ecology, *Handbuch politische Ökologie* (open access, transcript, 2022).

**Susanne Lachenicht** is Professor of Early Modern History at Bayreuth University, Germany. She works on Europe and the Atlantic World with a special focus on diasporas and nationhood, religious migrations, knowledge transfer and transformation as well as temporalities in the early modern world. Her more recent publications include (as ed. with Charlotte Lerg and Michael Kimmage) *The TransAtlantic Reconsidered* (Manchester University Press 2018/paperback 2020), (as ed. with Mathilde Monge) *Nations et empires*, thematic issue of *Diasporas. Migrations, circulations, histoire* 34/2 (2019), (as ed. with Marianne Amar, Isabelle Lacoue-Labarthe, Mathilde Monge and Annelise Rodrigo) *Négocier l'accueil / Negotiating asylum and accommodation*, thematic issue of *Diasporas. Migrations, circulations, histoire* 35/2 (2020) and (as ed. with Guido Braun) *Spies, Espionage and Secret Diplomacy in the Early Modern Period* (Kohlhammer 2021).

**Gesa Mackenthun** is Professor of American Studies at Rostock University, Germany. She works on the coloniality of knowledge, particularly in US discourse. Her books include *Embattled Excavations. Colonial and Transcultural Constructions of the American Deep Past* (2021), the co-edited 'Prehistory'. *Deep Time and Indigenous Knowledges in North America* (with Christen Mucher, 2021), and many edited volumes on the intersections between cultural encounters and scholarly/scientific discourses. She also did two books on oceans. More recently, she has published various critiques of the ideological uses of deep historical narratives, as well as on the sustainability of (future) stories. Her current research deals with representations of the transatlantic history of enclosures, evictions, and ecocide.

**Hans-Jürgen Puhle** is Professor (em.) of Political Science at Goethe Universität Frankfurt. He gained his PhD from Freie Universität Berlin (1965) and his Habilitation from the University of Münster (1973). He held appointments in history and political science at the universities of Münster and Bielefeld. He has also been visiting professor or fellow at Harvard, Oxford, Cornell, Stanford, Tel Aviv and other European, North and Latin American universities and research institutions. He has published extensively in the fields of European, North and Latin American social and political history, comparative politics, trajectories of modernization, political parties, movements, nationalism and populism, regime change, democratic (de-)consolidation and quality of democracy. Recent publications include *Protest, Parteien, Interventionstaat. Organisierte Politik und Demokratieprobleme im Wandel* (Göttingen 2015) and "Populism and Democracy in the 21st Century" (SCRIPTS Working Paper Series No. 2, 2020). He is member of the Excellence Cluster "Contestations of the Liberal Script" (Freie Universität Berlin). He currently researches recent changes of the structures of political intermediation and communication.

**Enrico Schlickeisen** graduated with a degree in English and History from the University of Rostock in 2019. Between 2019 and 2022, he worked on a dissertation on "Ideological Continuities in Right-Wing

Literature” exploring the transatlantic connections of the Alt Right movement. As of May, 2023, he works as a primary school teacher in Berlin.

**Christine Unrau** is a Research Group Leader at the Centre for Global Cooperation Research, University of Duisburg-Essen. Her research focuses on the nexus of emotions, narratives and politics, especially in the context of migration, humanitarianism and right-wing populism, as well as alter- and anti-globalization movements. Her book *Erfahrung und Engagement. Motive, Formen und Ziele der Globalisierungskritik* (transcript 2018) focuses on the motivations, forms and aims of political commitment in the Global Justice Movement. She has published in *Sustainable Development*, the *Journal of International Political Theory*, *Zeitschrift für Politische Theorie* and *International Political Sociology*.

**Aram Ziai** studied sociology, history and English literature in Aachen and Trinity College, Dublin. He has held research or teaching positions at the universities of Amsterdam, Hamburg, Bonn, Accra, Vienna, and Tehran. He is Professor of Development and Postcolonial Studies at the University of Kassel and Head of the Exceed Center “Global Partnership Network” (GPN). He published widely on postcoloniality and development discourse, including *Development Discourse and Global History: From Colonialism to the Sustainable Development Goals* (Routledge, 2017) and *The Development Dictionary @25: Post-Development and its Consequences* (Routledge, 2020).
