**Akteurinnen für urbanen Ungehorsam** is an interdisciplinary city research collective currently focusing on geographies and embodiments of invisible digital infrastructures and urban gig work. While we combine experience and expertise in fields such as architecture, communication design, and political and urban studies, our toolbox is based on critical feminist thinking as well as ethnographic research methods. With it, we tackle questions of cities in crisis, forms of dwelling, and ideas of future urban life. Currently, we do this mainly in and around Hamburg, Germany, as well as online.

**Sybille Bauriedl** is professor of geography with a focus on political ecology at the Europa-Universität Flensburg, Germany. Her research projects deal with local energy transition, platform urbanism, smart mobility, geographies of coloniality, and climate justice. She is a member of the German academy for territorial development, is engaged in interdisciplinary networks of energy geography and feminist geography, and is involved in the right to the city movement in Hamburg.

**Rabea Berfelde** is a PhD candidate in the Department of Media, Communications, and Cultural Studies at Goldsmiths, University of London. Her doctoral thesis, based on field research in Berlin, analyses the reconfiguration of labor and urban space under financialized digital capitalism.

**Filippo Bignami** is senior researcher and lecturer at the University of Applied Sciences of Southern Switzerland – LUCI (Labour, Urbanscape and Citizenship) research area. He holds a PhD in political and social sciences. Among scientific appointments, he has been external scientific consultant for the United Nations International Labour Organization (UN-ILO) and project-visiting professor at the Asia-Europe Institute, State University of Malaya, Kuala

Lumpur, Malaysia. His main scientific interest and expertise is in citizenship, social, and political theories, including applied studies on citizenship policies and education, urban transformation, and mega-events. He has coordinated many European and international research projects in this field.

**Yana Boeva** is a postdoc researcher at the Department of Social Sciences and the Cluster of Excellence *Integrative Computational Design and Construction for Architecture (IntCDC)*, University of Stuttgart. Her current research explores the transformation of design, architectural practice, and different user perceptions through computation and automation.

**Kathrin Braun** is research coordinator at the Center for Interdisciplinary Risk and Innovation Studies and postdoc researcher at the Department of Social Sciences, University of Stuttgart. She is a political scientist by training and her research focuses on Critical Biopolitics Studies, Science and Technology Studies, and Interpretative Policy Analysis. She is also co-editor of *Critical Policy Studies*.

**Emma Dowling** is tenure track professor for the sociology of social change at the University of Vienna, Austria. Previously she has held positions in the UK and Germany. Her research interests include social change and social justice; the financialization of the social; welfare state restructuring; labor, emotions, and affect. Her most recent work asks what our economy looks like when viewed from the perspective of care, charting the material conditions that shape its configurations. She is the author of *The Care Crisis – What Caused It and How Can We End It?* (2021, Verso Books).

**Yannick Ecker** is researcher and PhD student at Martin-Luther-University Halle-Wittenberg, Germany with a focus on urban geographies of precarization and digitalization. His research engages with the impacts of platformization on the production of space, social justice as well as gender arrangements and labor regimes. He has studied Urban Geographies at Humboldt-University, Berlin and is a former junior fellow of the Elisabeth-List-Program for Gender Research at University of Graz, Austria.

**Andreas Exner** is operational manager of the RCE Graz-Styria – Centre for Sustainable Social Transformation, University of Graz. Participating in and coordinating transdisciplinary research projects on alternative economies

and urban development, he focuses on social ecological transformation, including publications on Solidarity Economies and the Commons.

**Yvonne Franz** is an urban geographer at the University of Vienna. Her research interests lie in the fields of neighborhood development, urban arrival spaces, migration, housing market transition, and social innovation. She is also member of the interdisciplinary research platform *The Challenge of Urban Futures* and the co-director of the postgraduate course in Cooperative Urban and Regional Development at the Postgraduate Center, University of Vienna.

Her work focuses on the research and development of adaptive planning strategies to deal with uncertainties and dynamic urban futures in urban development and planning. Addressing challenges of planetary urbanization, decarbonization, decentralization of resources, and digitalization in spatial production and planning practice are central in her work towards sustainable and equitable urban futures.

**Thomas Höflehner** is a geographer and sustainability researcher and works as a postdoc researcher at the RCE Graz-Styria – Centre for Sustainable Social Transformation, University of Graz, Austria. His research focuses on inter- and transdisciplinary transition initiatives, integrated neighborhood development, participatory urban and regional development as well as cooperative innovation and change processes.

**Marisol Keller** is a PhD candidate and member of the labor geography group at the University of Zurich, Switzerland. Her autoethnographic research on the gig economy focuses on the social, spatial, and temporal working arrangements emerging in platform-mediated labor in Switzerland. She is also engaged in the community *Work* of the Digital Society Initiative at the University of Zurich which brings together scholars across disciplines to examine how technological advances and other forces are changing the world of work.

**Vicky Kluzik** works as a research associate in the Biotechnologies, Nature, and Society research group at the Institute of Sociology at Goethe University Frankfurt. Her research and teaching interests span from social theory, political economy, science and technology studies (STS) to cultural geography, with a specific focus on feminist and postcolonial theories to examine contemporary political, economic, and ecological crises in an interdisciplinary manner.
