Baltzer, Nanni, is a posdoctoral scholar at the Institute of Art History, University of Zurich (Switzerland). She worked as a researched assistant at the ETH Zürich, Canadian Centre for Architecture (Montréal), and at the Accademia di architettura (Mendrisio), and held various teaching positions at the University of Zurich and at the Zurich School of Arts.
