His expertise encompasses various aspects of medieval written culture, computer-assisted stemmatology, medieval hagiography, and monastic history. Heikkilä is currently one of the four Principal Investigators of *The Medieval Book and Networks of Northern Europe, c. 1000–1500: Texts, Crafts, Fragments*, a project funded by an ERC Synergy Grant (2025–2031). He is also the Principal Investigator of *Combining Humanities and Natural Science Research to Study Medieval Texts, Scribes, and Craftsmanship*, a project funded by the Finnish Research Council (2024–2028). Cordelia Heß is a Professor of Medieval History at Aarhus University. She held the Chair of Nordic History at the University of Greifswald between 2017 and 2024 and was the PI of the project “Saints and Heroes from Christianization to Nationalism: Symbol, Image, Memory (North-West Russia, Baltic, and Nordic countries).” Her research interests include the cultural and religious history of the Late Medieval Baltic Sea region, the history of antisemitism, and interreligious contact.
