

# PROBLEMS OF WOMEN IN DEVELOPING COUNTRIES A SELECTED BIBLIOGRAPHY

The present bibliography, "Problems of Women in Developing Countries", is a by-product of the thesis "Women in Rural Development in Developing Countries". The volumes compiled in this bibliography cover all those fields which are concerned with women's problems. In other words, traditional as well as modern spheres of duties and roles assigned to women are considered along with the related particular sectors. The studies in this bibliography cover countries in Africa, Asia, Latin America, and Oceania. Despite the very general title, there are gaps in the material covered by the present bibliography due to the emphasis laid on specific regions arising from the major interest of the author. The following works are largely anthropological or sociological. They vary greatly in their methods of research. The studies have been carried out on local, regional, national, and international levels. A number of crosscultural studies present either a comparison between countries with different cultures; compare sub-cultures within the same country and the same, or different, settlement areas; or present a comparison between developing countries. Not included in this bibliography is the extensive literature on family planning (so long as it is limited to the problem of family planning and does not go beyond it to include other questions concerning women); village studies, as in such studies women are considered from a specific point of view limited to the village and not under the aspect of women in general; and studies that are limited to research on customs and habits.

The material was divided according to particular geographical areas. In the general section, both works that are not related to a certain country as well as cross-cultural studies have been included.
