Dr. Nahed Ghazzoul is assistant professor of Linguistics. Currently, she is a full-time researcher at Paris Nanterre University in the MoDyCo Research Centre – PAUSE Programme. She holds a PhD in Linguistic from Lancaster University, UK from 2008; a Certificate in Learning and Teaching in Higher Education, from Lancaster University, UK from 2006; an MA in Linguistics (TESOL), University of Surrey, UK from 2004. She worked at different educational places including Aleppo University/Syria, Lancaster

Dr. David Gómez Gamboa is an associate professor at the School of Law of the University of Zulia (Venezuela). He has a degree in Law from the University of Zulia, 2000, and in Journalism from the Catholic University Cecilio Acosta, 2007. He did postgraduate studies in Human Rights at the University Complutense of Madrid and in Political Science at the University of Zulia. Currently, he is the founding director of Aula Abierta, a non-governmental organization that promotes academic freedom and university autonomy in Latin-America, and coordinator of the Law School's Human Rights Commission at the University of Zulia. Also, David is a human rights activist in the context of academic freedom and university autonomy. With his NGO, Aula Abierta, he denounces human rights violations in the Latin American university context.

Dr. Olga Hünler received her PhD in clinical psychology from Middle East Technical University in 2007. Between 2016 and 2019, she was granted the Philipp Schwartz Fellowship founded by the Alexander von Humboldt Foundation, and she was hosted at Bremen University, Germany. She was also an international guest researcher at the Margherita von Brentano Center for Gender Studies. She is currently an associate professor at Acibadem University, İstanbul.

His research focuses on varieties of internationalization and the politics of higher education reform in the Middle East and North Africa. He taught political science in Aix-en-Provence, Cairo and Lyon and is a former research fellow of CEDEJ in Cairo and alumnus of AGYA – The Arab German Young Academy of Sciences and Humanities.

Dr. Maggi W.H. Leung is professor in International Development Studies at the Department of Geography, Planning and International Development Studies of the University of Amsterdam.
