

## Acknowledgements

*Building Institution* presents research that has been underway for over fifteen years and began with my dissertation at the Institute for the History and Theory of Architecture (gta) at ETH Zurich (2007–11). During this time, the work took me to the Canadian Centre for Architecture in Montréal several times as a research student, to Columbia University in New York as a visiting researcher for a year, and to various archives and libraries (in addition to the Avery Library, also at the Massachusetts Institute of Technology, these include Princeton University, Yale University, and Sarah Lawrence College in New York State), and still bears traces of the network of all the intellectual and interpersonal relationships and interactions I enjoyed there. Since then, more than a decade has passed before the release of this publication, and in addition to the subject and method, i.e., institutional history, or indeed institutional analysis based on diligent archival research and a comprehensive oral history, this circumstance alone makes it almost impossible to fully acknowledge everyone for their contributions.

The book came about in a number of different institutional and thus also political contexts, and the project was shaped by the corresponding interests and values, opportunities and offerings: the Institute gta, where I was employed for three more years as a postdoctoral researcher (2012–15) following my dissertation, and where I was able to produce a first draft; the CCA, where I subsequently worked for three years as Associate Director of Research (2016–18) and contributed, among others, to the exhibition “Educating

Architects. Four Courses by Kenneth Frampton” (2017), as well as revising my manuscript once again after engaging in further archive research, especially in the recently acquired and not yet catalogued Kenneth Frampton Fonds; and the University of Manchester (since 2019), where, as a member of the Manchester Architecture Research Group, I was given the opportunity to finally translate my manuscript from German into English and transform it into a final version ready for publication.

As is so often the case in life and work in institutions, the production of this book was characterized by a process of converging and fading interests, of received and withdrawn verbal promises, of different capacities and needs, of opening up new paths and bearing the consequences. Given the task of combating the climate emergency and loss of biodiversity, however, it is hard to tell where to start, because we now know that transformation must be both rapid and comprehensive. Once again, the multifaceted, problematic, and ambivalent relationships with institutions must be explored anew, and it is up to everyone to decide for themselves whether to embark on the journey through existing institutions or to find other paths.
