Contemporary flows of immigrants, tourists and professional expats contribute to the emergence of multiculturally patterned interaction chains and to the emergence of a multilayered and negotiable concept of culture as a resource and playground rather than a ready-made software to be installed in individual minds during partially enforced socialization. Some of these patterned interactions will evolve into rituals and institutions, but not all of them, and most will require a continuous investment in maintenance and reengineering of relations and interaction processes.

Most of the professionals expedited by their companies and agencies to far away places are forced to dive into a cultural shock and re-adjustment. They develop their own cultural competence. In order to understand what they are doing and how they cope, we have to start with the study of re-tooling of cultures and subcultures (including the so called national ones managed by state bureaucracies, including ours) and of the consequences of individualization and hybridization of the ongoing process of identity formation, reformation and counterreformation. Studying the revolutionary consequences of reshaping of national cultures under the pressure of accelerated globalization and increase of unmanageable inequalities are at the core of our scientific programme.

### **3 x IN (Inventing – Innovating – Intrepreting)**

Breeding, facilitating and sustaining entrepreneurial and intrapreneurial initiatives requires approaching management as if it was a gerund rather than a noun. Innovating means seeing realities as flows and processes, streams and currents rather than bricks or blocks of organizational structures neatly displayed in solid organi-grams. Non-hierarchic, network-oriented and self-managed-teams-based matrixes of future forms of organizing call for research attention of academic and non-academic communities of practice. Dealing with manageable inequalities, minding and mining diversities or breaking with bureaucratic routines without getting rid of traceable responsibilities – those are the new skills and insights which call for inventions, innovations and continuous self-reflexive interpretations (and re-interpretations, and re-re-interpretations and more). 3 x IN focuses on breeding cross-cultural competence and on eVolving. Competent scanning of organizational windows of opportunities and practical adjustment of managerial narratives and academic discourses to changing realities of postglobalized, de-communized and post-Chindianized interactions are among challenges ahead. Let us start tackling them.

A group of researchers spanning cross-cultural studies, critical management studies and sciences of organization invite you to discuss theoretical landscape of comparative studies in cultures and organizations. Selected papers submitted to both conferences will appear in European Journal of International Management, Journal of Organizational Change Management, Journal of Cross-Cultural Competence & Management and International Journal of Cross-Cultural Management. The mission of IACCM members is to promote scholarly work of young scholars in Europe.

The Czechoslovak Society of Arts and Sciences will hold its 24th World Congress in Ruzomberok, Slovakia from September 8 to 14, 2008. The Congress will commemorate the 50th anniversary of the foundation of the Czechoslovak Society of Arts and Sciences and will be cosponsored by the Catholic University and the City of Ruzomberok.

The special session will underscore recent developments in managerial integration of scientific, engineering, and business practices in contemporary corporations, institutions, and organizations with particular emphasis on Central and Eastern Europe. Issues concerning integration of managerial practices will be examine in the framework of entrepreneurship, innovation, and commercialization with a focus on the formation of smaller enterprises, spin-offs from scientific and academic research, and strategic marketing. Scientists, academics, and practitioners are encouraged to submit papers for presentations.



Submitted papers will be refereed and authors will be notified regarding the final acceptance of their submissions. Research papers, case studies, concepts and policy papers are welcome.

The session will be held in English; contributors from all countries interested managerial integration of scientific, engineering, and business practices are invited to participate. A special invitation is extended to potential contributors from the Czech and Slovak Republics and international doctoral students interested in managerial issues concerning the Czech and Slovak Republics. Papers should not be more than fifteen pages in length, written in English, and should be prepared according to the University of Chicago style manual (K.L. Turabian, A Manual for Writers. Chicago: The University of Chicago Press, 1987). Papers are due **February 29, 2008**. Authors will be notified by **March 14, 2008** regarding their acceptance. Final papers will be due **May 16, 2008**. All submissions must be made by electronic mail using a standard Microsoft Word program. **Apparent Antitheses**

**Globalisation and Local Development Development**

**9 – 11 October 2008**

**Trento, Italy**

**1. Background and issues:**

The international conference addresses the apparently antithetic relation existing between globalisation and local development from an interdisciplinary and comparative perspective.

Increasing openness, interaction, and integration of economies, politics, societies and technologies, should lead to convergence of structures, practices and standards. In an alternative scenario based on distinctive socio-economic systems (“national capitalisms”), convergence is not a necessary – and not even a likely outcome of globalisation. This is so for different reasons that span from the role of distinctive competences and path dependence to the instability of globalisation processes that continuously alter the conditions for and the requirements of adaptation.

More recently, theoretical and applied research on localised competences and dynamic legacies of the firm, actual features of delocalisation, social capital at micro-and meso-level, cultural and social interpretations of technology, multilevel governance and subsidiarity have opened new perspectives and new questions for local development.

The three perspectives tend to highlight different aspects of globalisation and local development. From them, a host of important questions descend. If globalisation has homogenising effects, that are at the origin of asymmetric shocks for local constituencies, in different situations and presenting diverse features, can local development be an efficacious adaptation mechanism? Since globalisation strongly limits and constraints the ability of national governments to use macro-policies for governing the economy and society, can local development offer a viable governance solution, perhaps together with the upsurge of micro-policies? Social and political stability and competitiveness in a globalising context requires the mobilisation, use and coordination of dispersed resources and capabilities: can local development enjoy sizeable and appropriable advantages under this perspective? Which are the institutions and policy means that can reconstruct the entirety and complexity of processes and coordinate decisions and activities?

There are various signs suggesting that globalisation, along with its homogenising effects, has important outcomes for the valuable use of distinct and idiosyncratic features and abilities. Is local development an efficacious provider of variety to meet the increasing variety of tastes and the needs of modular technologies? Can local development act as an insurance device by providing a variety of solutions to unforeseen events and situations, that globalization brings about? Will different localities endowed with different local development experiences play a different role in the globalisation process and pursue different types of specialisation? Which consequences will this have for countries?

A particular but fundamental type of globalisation is the one which characterises the natural environment. The strain that is jeopardising the environment and fostering a quest for sustainability may require a new holistic approach to manage threats and foster a sustainable approach to global development: can local development offer solutions by anchoring activities in local constituencies which are supposedly more sensitive to environmental issues?

## **2. Topics**

Papers can deal with topics in the domain of the conference themes, such as:

- Local development according to the prevailing paradigms;
- Institutions and policies: the coordination of decisions and activities in a locally based global world;
- Mobilisation of dispersed resources and capabilities;
- Local government as a governance mechanism: micro-policies, multilevel governance;
- The quest for variety and the role of local development;
- Local development as an adaptation mechanism in case of asymmetric external shocks;
- Local development as an insurance against unforeseen and asymmetric events;
- Local development as the basis for a new holistic approach to environmental sustainability.

Topics may be afforded both in theoretical and in applied terms, using case studies or a comparative approach, and may refer to developed, developing or transformation countries. Innovative ideas and approaches are welcome.

## **3. Conditions for participants**

The Conference Academic Committee is now calling for papers to be presented at the conference.

Applicants should send an abstract not exceeding 500 words, and Curriculum Vitae no longer than one page with up to 10 publications. Abstracts must be addressed to: [alice.valdesalici@economia.unitn.it](mailto:alice.valdesalici@economia.unitn.it), and are expected by March 15, 2008. The Committee will notify applicants by April 15, 2008. Papers of

selected applicants are due in electronic form (pdf) by September 15, 2008. Accepted papers will be taken into consideration for a special publication.
