Acknowledgements

This was a different world. Unlike in *Moria*, there was not always an urgent next thing to do. There was space and time for thought and reflection. The Institute offered me a truly wonderful space to discuss, learn, read, write, think, and discuss again. We had time for concentrated research, and we were given the possibility to follow our inclinations and interests.
