His research focuses on international migration, citizenship, and social and development policies. Currently, he is involved in research projects on environmental degradation and forced migration and on transnationalisation and social

transformation. His recent book publications include *Dual Citizenship in Europe: From Nationhood to Societal Integration* (Ashgate 2007; reprint 2008), *Citizenship: Discourse, Theory and Transnational Prospects* (with Peter Kivistö, Blackwell, 2007), and *Dual Citizenship in a Globalizing World: From Unitary to Multiple Citizenship* (Palgrave Macmillan 2007; reprint 2008).
