SCCAC Announces New Book Series

The Society for Conceptual and Content Analysis by Computer finally succeeded in publishing the papers of its 12 meetings in its 10 years of existence in a book series of its own entitled: *Concepts - Content - Meaning* published by Intellect Books, Oxford, U.K. The title of the first volume, which is now in production is *From Information to Knowledge*. The series is edited by Ephraim Nissan and Klaus M. Schmidt with Sally and Walter Sedelow being the editorial advisors. The SCCAC Newsletter No.6, 1993, lists the 20 articles and their authors of this first volume and includes also those abstracts not as yet previously published. The contents of the volume has been arranged in four parts: General Text Analysis, Content Analysis, From Data to Meaning, The Struggle for Acceptance.
