UDC Computerization Working Party Appointed

FID has recently appointed a Computerization Working Party for the Universal Decimal Classification. The objective of this Working Party is to establish a UDC file, making use of already available machine-readable data, to facilitate the revision, publication and computerized application of the UDC.

The first meeting was held in Berlin, August 1986 and concentrated on the development of an experimental file for a machine-readable version of the Universal Decimal Classification.

Willem de Regt †

The chairman of the Central Classification Committee (FID/CCC) of the UDC, Willem DE REGT, died on Dec.20, 1986. He had been the director of the documentation services of the Netherlands Ministry of Education and Science. He was a member, secretary and later on also the vice-chairman of the UDC Revision Committee C3 (Social Sciences).

UDC Management Board

On Dec.8, 1986 a constituting meeting of this new Board - replacing the former FID/CCC - took place at The Hague. Its members are: The Classification Director of the FID General Secretariat, an FID Council Member, the Chairmen of the Coordination Committees of the UDC and some selected experts. Prof.Dr.A.B.Frielink was elected chairman.

The major tasks of this Board will be: system development, revision strategy and planning, responsibility for all contracts in connection with a publication of the UDC, public relations, computerization and finally financing and planning of finances.

The first meeting of this UDC Management Board has been planned for March 1987.

triennial series. Each annual issue contains all proposals accepted during the past year, and also cumulates previous issues in the same series. Series 12, No.3 has been published in 1986, priced 195 Dutch guilders. This cumulates the changes and additions which appeared in Series 12, No.1 published in 1984 and Series 12, No.2 published in 1985 with the proposals accepted during 1985. Series 13, Nos.1, 2 and 3 will be published in 1987, 1988 and 1989.

Report on the 1986 Cataloguing and Classification Seminar/ Workshop, Ibadan, Nigeria

The 1986 Annual Seminar/Workshop organised by the Cataloguing and Classification Section of the Nigerian Library Association was held at the Conference Centre, University of Ibadan, from July 9 to 11, 1986.

1. Opening Ceremony

The opening ceremony was presided over by Mr.J.O. Dipeolu, University Librarian, University of Ife. In his opening speech, the Chairman praised the relentless efforts of cataloguers in seeing to the proper organization of library materials. He enjoined the Cataloguing and Classification Section to keep up the good work and the tradition for continuing education already established by the Section. Also present at the opening ceremony and seated at the honoured table were the Acting University Librarian of the University of Ibadan, Mr.F.O.Aramide who gave a warm welcome address; and Mr. M.H.Wali, the Director, National Library of Nigeria, who was a special guest of honour. Mr.Wali, in his good will address, acknowledged the efforts of the Section since 1966, towards standardizing the practice of cataloguing and classification in Nigeria; he praised the able leadership of the Chairperson, and pledged his continued support for the Section in his double capacity as the Director, National Library and Vice-President of FID. Mr.Wali is particularly interested in the establishment of a Sub-Committee on UDC in Nigeria which will, among other related activities, pro-

mote the use of the UDC scheme in Nigeria. Before concluding his speech, he promised to provide assistance for research and training workshops on the application of the UDC scheme in Nigerian libraries.

Prominent among the important personalities on the high table, was the President of the Nigerian Library Association, Mr.J.A.Dosunmu, who, in his brief address, described the Cataloguing and Classification Section as the most cherished baby of the NLA. Mr.Dosunmu stressed the point that the efforts of the Section for the past twelve years, have helped in raising the status of Nigerian librarians internationally. The role of the Section in making it possible to train and retrain librarians in the use of international standards from time to time, has endeared the Section to the hearts of librarians in Nigeria and outside Nigeria.

After another welcome address by the Chairman of the Oyo State Division of the NLA, Mr.M.O.Afolabi, the Commissioner for Information, Social Development, Youths, Sports and Culture, Oyo State, Alhaju Bola Adedaja, performed the official opening of the seminar. In a stimulating address, the commissioner expressed his delight in the theme of the seminar/workshop. He noted particularly the value to research of the knowledge in the use of the library catalogues, the need for cooperation among libraries, the unique position occupied by libraries in the developmental goals of a nation, and urged librarians in Nigeria to find lasting solutions to the problems in the classification schemes, solutions, which can be exported to other African countries.

Other important personalities seated at the high table were Prof. (Mrs.)F.A.Ogunsheye, Prof.(Mrs.)B.O.Aboyade, Head of the Dept.of Library Studies and Mr.E.B.Bankole, retired University of Lagos Librarian, who is now the Managing Director of Liberi-Service, Ltd.

At the end of the impressive ceremony, the Chairperson of the Section, Mrs.B.S.Bankole gave a pleasant and delightful vote of thanks to the special guest on the high table, to members of the NLA Council, who broke up their meeting to attend the opening ceremony, to members of the planning committee and to all the participants.

2. Theme

The theme of this year's conference is the consideration of "Problems with the application of the major classification schemes used in Nigerian Libraries". The major schemes discussed are the Library of Congress Classification, the Dewey Decimal Classification, the Universal Decimal Classification and Moy's Classification scheme for Law. Since these schemes have been found to be inadequate in classifying Africana materials, some major libraries have made adaptations to the schemes. These adaptations were examined and discussed. Since the period of three days was not enough to do justice to all the various adaptations, the participants resolved to continue the work of collating and synthesizing all the adaptations for adoption in all the Nigerian libraries nationwide, through sub-committees.

3. Registered Participants

A total of seventy-three (73) librarians from different libraries all over Nigeria, registered for the seminar/workshop. These were librarians from university and college libraries, special and research libraries and from government and public libraries throughout the country.

4. Papers presented

Papers presented during the seminar/workshop include a very stimulating and an indepth study of the problems and prospects of classification of Africana, by a veteran cataloguer, Mr.N.Amankwe, Deputy University Librarian, University of Nigeria, Nsukka. This was presented as a keynote paper entitled "Classification of Africana: problems and prospects". This paper discussed the problems encountered with the use of all the major schemes, mentioned above, and blamed the negative attitude of our young professionals to cataloguing and classification, on the method of teaching in the library schools, which is devoid of intellectual stimulant, required for the development of keen interest in cataloguing and classification. It traces the history and the development of the major classification schemes, points at their weakness and strength and suggests concrete approaches to, and alternative in the modification of the weak areas.

- "...Problems with the application of DDC and LCC to agricultural and veterinary medicine materials" by Mr.Kingsley F.Okocha, National Root Crops Research Institute Umudike, Umuahia, Imo State; Mr.Olukayode Okanlawon, Veterinary Medical Library, ABU, Zaria; and Mr.G.O. Ibekwe, International Institute of Tropical Agriculture, Ibadan.
- "The classification of African materials in social sciences and education by the Library of Congress Classification; problems and solutions made so far" by Mrs.A.Faniran, University of Ibadan, Law Library.
- "The use, problems and prospects of adaptation of the Library of Congress Classification Scheme in Nigerian Libraries: the experience of the Ahmadu Bello University Library with the treatment of ethnography in class GN", by Mr.John A.Abu, Kashin Ibrahim Library, ABU, Zaria.
- The use of Moys Classification Scheme for law materials in Nigeria" by Mrs.Oluremi Jegede, Institute Librarian, Nigerian Institute of Advanced Legal Studies, Lagos.

All the papers were stimulating and interesting; they generated informative and fruitful discussions.

5. Working Committees

During the seminar/workshop, working committees were set up on each of the four classification schemes. Each committee is to examine, study and collate all the adaptations already made by different libraries to its classification scheme. For example, the Working Committee on Library of Congress Classification will collate all the adaptations in use in different libraries, study them, amend them if necessary, and prepare them for adoption by libraries in Nigeria.

6. Resolutions

Three resolutions were passed at the end of the seminar/workshop. These are:

- 1) That in view of the fact that many adaptations and modifications are made to the major classification schemes used in Nigerian libraries, the NLA, Cataloguing and Classification Section should set up sub-committees that will look into these modifications and work towards their adoption nation-wide.
- 2) That the National Library of Nigeria should acquire the latest editions of the major classification schemes used in Nigerian libraries and make them available for purchase by interested libraries.
- 3) That in view of the fact that UDC users are few and scattered all over the country, the NLA Cataloguing and Classification Section should support the sub-committee on UDC and others by making funds available for the smooth running of the work of the committees.

7. Special Report on the discussions on UDC

The discussion on UDC is very remarkable because, apart from the fact that an examination of the UDC scheme featured for the first time in our annual seminar/workshops since 1980, the discussion this year revealed many facts about the use of UDC in Nigeria, which were hitherto not known. For example, while it was reported in Monica Greaves' paper that sixteen libraries use the UDC, it was further discovered during the committee meeting that at least twenty-one (21) libraries use the scheme. During the meeting of the sub-committee on UDC, set up during the Workshop, members present discussed certain problems peculiar to UDC users. These problems include:

- 1) The lack of training courses for UDC users.
- 2) Difficulties in getting copies of the schedules.
- 3) High cost of the schedules and the problems of foreign exchange needed for the purchase.
- 4) Lack of communication among the users of UDC in Nigeria.

It was unanimously resolved during the meeting of the sub-committee on UDC to request for assistance from FID through its Vice-President for the African Region, Mr.M. H.Wali. This help may be in the form of:

- 1) making copies of the different editions of the UDC scheme available for purchase in Nigeria.
- 2) Financial assistance for the promotion of the work of the committee.

It is hoped that the work of the committee will embrace a thorough study and examination of the application of the UDC schedule to African materials or to specific African and local subjects. It was discovered during discussions that problems with the use of UDC in Nigeria are in the areas needing revision, and difficulties of numbers changing in the new editions; more so, when the new editions are difficult to obtain. We hope that, in fulfilment of the promise made by the Vice-President of FID in his special address, the Sub-Committee on UDC will be assisted in carrying out the functions listed in the address.

I take this opportunity to express our gratitude to the Directorate of the National Library for its continued support for the Section and for allowing me and the Secretary to fulfil our responsibilities to the Section. I assure the Director that this opportunity, like a double-edged sword, is not only fostering the objectives of the Section, but is also enhancing our usefulness to the services of the National Library of Nigeria.

U.K CRG 259

The 259th meeting of the Classification Research Group was held on December 11, 1986 at University College London with eleven members present. Mr. BONNER introduced the principal features of his Classification of phenomenon-based classes. He examined the origin of the term "phenomenon" and drew the meeting's attention to an exhaustive list of levels (of complexity) placing disciplines in relation to phenomena in the universe of knowledge. He next considered various defini-

tions of "discipline" and showed how he had arrived at a classification of types of discipline. The following ones of this typology were discussed at the meeting: Pure disciplines, megadisciplines (rational and non-rational), descriptive and explanatory disciplines, prescriptive, impure disciplines, subdisciplines, fields of knowledge and finally problem based and mission based disciplines. Mr. Bonner stated that the problem with phenomenon-based classes was that they could not be logically subordinated to a discipline class. The discussion on Mr. Bonner's Classification of phenomena will be continued at the next meeting.

U.K.: CRG 260

The 260th meeting was held at University College London on Febr.5, 1987 with nine members present. Mr. BONNER outlined the thinking behind the principles that evolved as the basis of his thesis. These principles and rules were those which he thought particularly relevant to the classification of classes outside the context of disciplines, (e.g. that phenomena which depend for their existence and/or behaviour on other phenomena, should file after these other phenomena; or, that concepts required to define other concepts should file before the other concepts; or, that parts, processes actions, attributes, faculties and products should be subordinated to the wholes or systems of which they are, by definition, a part or else originate from it). To these 15 principles and rules, summarized on four pages and extended by a page with six types of facets arranged in filing order, a classification of phenomenon-based classes was added with an illustrated outline of three pages. Most of the rules and the outline were discussed during the meeting.
